You must have a valid multiple UK short-stay ("C") visa in order to travel to Ireland from the UK und this programme.	
In order to avail of the programme you must have landed and gained lawful entry to the UK on foot of your current UK visa, prior to undertail the journey to Ireland. Each distinct period of leave to remain in the UK (up to a maximum of 180 days each time) requires a prior legal entite into the UK before travel to Ireland under the programme, no matter what the duration of the UK visa.
