Required Documents for Birth Registration

An Italian citizen who needs to
register his/her child's/s' birth record
in Italian commune (Please check
Eligibility paragraph).

Family certificate, a copy of the oath certificate and historical residence certificate issued from Italy attested from issuing authority in Italy.

In case of minor applicant, parents' passport or soggiorno, identity card's copy attested from issuing authority along with historical residence certificate in Italy of the Italian parent, copy of the oath certificate of the Italian parent.

For adults, passports (2,3,4,5) and ID card's copy.

Original Birth Certificate apostilled and translated in Italian from authorized translation center.

The compulsory request of registration transmission (Registration Form) must be addressed using the form available at website http://www.vfsglobal-it-bd.com to Consular Office of the Embassy of Italy in Dhaka, signed in original and filled in by the Italian Citizen for the child. For adult, applicant him/herself will sign and in both cases with copy of Italian passports enclosed (page 2,3,4, and 5 in one page) and the copy of Carta D Identita, attestation not required. Application details form.

Note:

Registration form for birth must be signed in original by the Italian citizen and applicant can submit in person or through an authorized agent) to the VFS, who will forward them to the Italian Embassy in Dhaka for the final verification and legalization.

- Applicants are kindly requested to refrain from showing up directly at Embassy for legalization and registration purposes.
- Incomplete application will be sent back and those who presented fraudulent documents will be reported to competent Italian and Bangladesh police and judiciary authorities.
- In case of the application is to submit by other than the applicant/Italian citizen (parent), a proper authorization letter for representative is a must.

Following Steps:

- As mandated by the law, the Embassy will keep the original birth certificate in their archives and a certified truly copy of the birth will be sent by the Embassy to the competent Italian Municipality for the necessary registration and updating of the records concerning Italian nationals.
- A copy of the Protocolled Transmission Registration Note will be handed over to the applicants through VFS.

Eligibility:

- A child born after parent's acquiring the Italian passport if the Italian parent was legally resident in Italy for more than two years after the date of the oath and before the birth of the kid (historical certificate of residence is required).
- A child born before his/her parent's acquired Italian passport if by the time the child was legally resident in Italy with the family for more than 2 years or, if the kid is less than 2 years old, since his/her birth (historical certificate of residence is required).

Embassy of Italy reserves the rights to ask for additional documents/s.

SPECIAL CASE

• If one of the parents is Italian by birth, the parents can jointly present a request of recognition of the Italian Citizenship of his/her kid within one year from the date of birth. VFS will supply specific application forms to be filled in and the application will be followed directly by the Embassy.
