In order to submit your application, please make sure to bring all the documents listed below on the day of your appointment. Please be aware that if further verification is required this Consulate's citizenship office can request additional documents beyond the ones listed here and provided by the applicant, in order to determine the applicants' eligibility for Italian citizenship.

GRANDPARENTS' DOCUMENTS

- ☐ birth certificate (from Italy) of grandparent born in Italy
- ☐ copy of other grandparent's birth certificate
- ☐ marriage certificate with apostille (or) marriage certificate from Italy

IF APPLICABLE



- ☐ divorce certificate with apostille
- ☐ death certificate of grandparent born in Italy with apostille
- ☐ copy of other grandparent's death certificate

NATURALIZATION DOCUMENTS

- ☐ Evidence of Australian Citizenship Certificate with apostille

OR

NON-NATURALIZATION DOCUMENTS

- ☐ VEVO

Or

- ☐ "No record statement" issued by the Australian Home Affairs Department, with apostille

PARENTS' DOCUMENTS

- ☐ birth certificate of Italian ascendant (parent) with apostille
- ☐ copy of other parent's birth certificate
- ☐ marriage certificate with apostille

IF APPLICABLE



- ☐ divorce certificate with apostille
- ☐ death certificate of Italian ascendant (parent) with apostille
- ☐ copy of other parent's death certificate

APPLICANT'S DOCUMENTS

- ☐ **birth certificate** with apostille and translation
- ☐ **valid passport** – original and a copy
- ☐ **driver licence** – original and a copy
- ☐ **Payment** can be made by Debit/Credit Card (VISA/MASTERCARD) or cash in Australian dollars

IF APPLICABLE



- ☐ evidence of permanent residency (VEVO), if not Australian citizen
- ☐ marriage certificate with apostille and translation
- ☐ copy of spouse's birth certificate
- ☐ divorce certificate with apostille and translation
- ☐ copy of spouse's death certificate
- ☐ additional marriage certificate with apostille and translation
- ☐ minor child's birth certificate with apostille and translation

IMPORTANT NOTICE: ALL certificates including originals WILL NOT BE RETURNED

Please note that prior to your appointment, any document issued in a country other than Italy or Australia that is part of your application must be authenticated, translated, and legalized for use in Italy in the country of origin. Our recommendation is to get in contact with the Italian diplomatic authority (Consulate or Embassy) in the country in which the certificate was issued to find out about the specific authentication process.
