



## ITALY – Checklist for Business Visa

	<ul style="list-style-type: none"> <li>One Visa application form which <b>must be completed in English</b> and signed by the applicant.</li> </ul>	
	<ul style="list-style-type: none"> <li>2 recent passport photos <b>40 x 60 mm</b> white background (please visit <a href="https://visa.vfsglobal.com/kwt/en/ita/apply-visa">https://visa.vfsglobal.com/kwt/en/ita/apply-visa</a> (for further info).</li> </ul>	
	<ul style="list-style-type: none"> <li><b>Original Passport</b> valid for at least 3 months from the date of return. Copy of Passport and previous Schengen visas issued during last 3 years. The passport must have at least two blank pages (face to face).</li> </ul>	
	<ul style="list-style-type: none"> <li>Photocopy of current passport and Civil ID. Copy of resident permit valid for minimum 3 Months after return date.</li> </ul>	
	<ul style="list-style-type: none"> <li>Proof of available <b>lodging</b> in Italy and all other Schengen Countries (<b>hotel booking or accommodation proof</b>) valid for the entire duration of the trip to the Schengen Countries. Please note that the majority of stay will have to be in Italy.</li> </ul>	
	<ul style="list-style-type: none"> <li><b>Air ticket</b> booking and copy to any destination in Italy or train tickets or Car reservation.</li> </ul>	
	<ul style="list-style-type: none"> <li><b>All Risk Health and Travel Insurance</b> with minimum coverage of EURO 30.000,--per person valid for all Schengen Countries and for the entire duration of stay. Travel Insurance with a verifiable barcode should be submitted.</li> </ul>	
	<ul style="list-style-type: none"> <li><b>Invitation letter</b> from the Italian company, please visit, <a href="http://vistoperitalia.esteri.it/Moduli/it/LetteradiinviatoperAFFARI.pdf">http://vistoperitalia.esteri.it/Moduli/it/LetteradiinviatoperAFFARI.pdf</a> for the format <b>Italian Company's Profile</b>, issued by the C.C.I.A.A. - Italian Chamber of Commerce &amp; Industry (VISURA CAMERALE).</li> <li>Copy of ID or Passport of the person who signed the Invitation letter.</li> </ul>	
	<p><b>Financial means</b></p> <p>➤ For visa-applicants (<b>Non – Kuwaiti Residence</b>):</p> <p><b>Original salary certificate</b> (Letter from your Sponsor/Employer, addressed to the Embassy of Italy providing the following: date of your employment, position held, monthly salary, duration of your authorized trip).</p> <p><b>Authorized Signature (اعتماد توقيع)</b> issued by the Kuwaiti Ministry of Social Affairs &amp; Labor with the authentication of Kuwait Chamber of Commerce &amp; Industry.</p> <p><b>Original bank Statement:</b> last 6 months of transactions, with the exact salary, stamped at the bank or printed on the bank paper. (Proof of economic means of support).</p> <p><b>Copy of valid Kuwaiti work permit.</b></p> <p>➤ <b>Kuwaiti Nationals</b></p> <p><b>Original salary certificate</b> in English or translation must be provided along with the authorized signature issued by the Kuwaiti Ministry of Social Affairs &amp; Labor with the authentication of Kuwait Chamber of Commerce &amp; Industry <b>OR</b></p> <p><b>Original bank Statement</b> featuring the last 3 months of transaction (in English or translation must be provided) <b>OR</b></p> <p><b>Original Credit card</b> statement with credit limit clearly mentioned(in English or translation must be provided)</p>	
	Additional supporting documents may be requested in some cases.

- The visa must be applied for in person
- All documentation must be submitted in English language
- Original documents must be presented along with photocopies.
