



## ITALY – Checklist for Business Visa

	One Visa application form which <b>must be completed in English</b> and signed by the applicant.	
	2 recent passport photos <b>40 x 60 mm</b> white background (please visit <a href="http://www.vfsglobal.com/Italy/Kuwait/English/tourist.html">www.vfsglobal.com/Italy/Kuwait/English/tourist.html</a> for further info).	
	<b>Original Passport</b> valid for at least 3 months from the date of return. Copy of Passport and previous Schengen visas issued during last 3 years. The passport must have at least two blank pages (face to face).	
	Copy of the civil ID Copy of resident permit valid for minimum 3 Months after return date.	
	Proof of available <b>lodging</b> in Italy and all other Schengen Countries ( <b>hotel booking or accommodation proof</b> ) valid for the entire duration of the trip to the Schengen Countries. Please note that the majority of stay will have to be in Italy.	
	<b>Air ticket</b> booking and copy to any destination in Italy or train tickets or Car reservation.	
	<b>All Risk Health and Travel Insurance</b> with minimum coverage of EURO 30.000,--per person valid for all Schengen Countries and for the entire duration of stay. Travel Insurance with a verifiable barcode should be submitted.	
	<b>Invitation letter</b> from the Italian company, please visit, <a href="http://vistoperitalia.esteri.it/Moduli/it/LetteradiinvitoperAFFARI.pdf">http://vistoperitalia.esteri.it/Moduli/it/LetteradiinvitoperAFFARI.pdf</a>  Italian Company's Profile, issued by the C.C.I.A.A. - Italian Chamber of Commerce & Industry (VISURA CAMERALE). Copy of ID or Passport of the person who sign the Invitation letter.	
	<b>Financial means</b> For visa-applicants ( <b>Non – Kuwaiti Residence</b> ): <b>Original salary certificate</b> (Letter from your Sponsor/Employer, addressed to the Embassy of Italy providing the following: date of your employment, position held, monthly salary, duration of your authorized trip). <b>Authorized Signature</b> (اعتماد توقيـع) issued by the Kuwaiti Ministry of Social Affairs & Labor with the authentication of Kuwait Chamber of Commerce & Industry. <b>Original bank Statement:</b> last 6 months of transactions, with the exact salary, stamped by the bank or printed on the bank paper. (Proof of economic means of support). <b>Copy of valid Kuwaiti work permit.</b>	
	Additional supporting documents may be requested in some cases.

- The visa must be applied for in person
- All documentation must be submitted in English language
- Original documents must be presented along with photocopies.
