	<ul style="list-style-type: none"> 1 Recent (3 Months old) Passport size photos 40 x 60 mm white background (please visit https://visa.vfsglobal.com/kwt/en/ita/apply-visa (for further info). 	
	<ul style="list-style-type: none"> Original Passport valid for at least 6 months from the date of return. Copy of Passport and previous Schengen visas issued during last 3 years. The passport must have at least two blank pages (back-to-back). 	
	<ul style="list-style-type: none"> Photocopy of current passport and Civil ID. Copy of resident permit valid for minimum 3 Months after return date. 	
	<ul style="list-style-type: none"> Proof of available lodging in Italy and all other Schengen Countries (hotel booking or accommodation proof) valid for the entire duration of the trip to the Schengen Countries. Please note that the majority of stay will have to be in Italy. 	
	<ul style="list-style-type: none"> Air ticket booking and copy to any destination in Italy or train tickets or Car reservation. 	
	<ul style="list-style-type: none"> All Risk Health and Travel Insurance with minimum coverage of EURO 30.000, --per person valid for all Schengen Countries and for the entire duration of stay. Travel Insurance with a verifiable barcode should be submitted. 	
	<ul style="list-style-type: none"> For children under 18 years of age: In addition <ul style="list-style-type: none"> For children travelling with Parents <ul style="list-style-type: none"> Copy of parent's passport first page with signature & second page and valid Schengen visa. Copy of parent's civil id. Birth certificate of the child translated in English. Translated death certificate and custodianship sentence where applicable. For students: proof of enrolment in school/university. Parental Authorization form must be filled in English https://www.vfsglobal.com/one-pager/italy/kuwait/english/#Tourist In case of parents not traveling with the child. <ul style="list-style-type: none"> Copy of parent's passport first page with signature & second page Copy of parent's civil id, Copy of the passport and the valid Schengen visa of the accompanying person. Birth certificate of the child translated in English. Translated death certificate and custodianship sentence where applicable. For students: proof of enrolment in school/university Parental Authorization form must be filled in English https://www.vfsglobal.com/one-pager/italy/kuwait/english/#Tourist For non – Kuwaiti Residence: In the case if the current photograph of the child is not visibly similar to the photo in their passport. A photo affidavit is required from their respective embassies in English. <p>Kindly Note for children under 18 years of age, both parents need to visit the visa application center at the time of the appointment.</p>	
	<ul style="list-style-type: none"> Financial means <ul style="list-style-type: none"> Non – Kuwaiti Residence Original salary certificate (Letter from your Sponsor/Employer, addressed to the Embassy of Italy providing the following: date of your employment, position held, monthly salary, duration of your authorized trip). Copy of valid Kuwaiti work permit. Authorized Signature (اعتماد توقيع) issued by the Kuwaiti Ministry of Social Affairs & Labor with the authentication of Kuwait Chamber of Commerce & Industry. Original bank Statement: Applicants must prove to have sufficient economic means of support, as per the Italian Ministry of Interior Directive 01.03.2019. In particular they are required to enclose an original bank statement (stamped by the bank or printed on the bank paper) featuring the last 6 months of transactions. The statements must prove sufficient funds to cover all the expenses connected to the travel and stay in Italy. The bank statement must also feature the transactions connected to the monthly salary Kuwaiti Nationals Original salary certificate in English or translation must be provided along with the authorized signature issued by the Kuwaiti Ministry of Social Affairs & Labor with the authentication of Kuwait Chamber of Commerce & Industry OR Original bank Statement featuring the last 3 months of transaction (in English or translation must be provided) OR Original Credit card statement with credit limit clearly mentioned(in English or translation must be provided) 	
	<p>Additional documents and copies might be requested in some cases.</p>	

	<p>For Applicants who are holding below nationalities should also provide birth certificate and national ids. (Pakistan, Afghanistan, Bangladesh, Palestine, Yemen, Iraq) Applicants holding travel documents are required to submit a birth certificate translated into English * In Additional for non-Kuwaitis marriage certificate is also required. (Translated in English)</p>	
	<p>Additional documents and copies might be requested in some cases.</p>

- The visa must be applied in person.
- All documentation must be submitted in English language.
- Original documents must be presented along with photocopies.
- Kindly note for families applying together must submit separate set of copies of financial means.
