## Documents required for Schengen Visa applications

E-Application form – duly completed on line, website <a href="http://e-applicationvisa.esteri.it">http://e-applicationvisa.esteri.it</a>
You need to print it, 4 pages and the bar code page, and sign it.
If the applicant <b>is a minor</b> (under the age of 18) both parents/legal guardian must sign the application form.
Minor and both parents must be present at the VFS center during the application process
Passport - valid for at least 3 months from the date of return and there must be at least two blank pages in the
document
document
Photocopy of relevant passport pages:
data page, previous Schengen , UK and USA visas
uata page, previous schengen, or and osa visas
Photocopy of Omani residence visa and resident card , for non-Omani Nationals
The residence permit must be valid for at least 3 month after the end of the planned trip and must be in the
current passport
A recent passport sized <b>color photograph</b> with a white background (3.50X4.50cm).
Head covering are only accepted for religious reasons, please see "Photo Specification" link
Healthcare documentation including:
-
a) medical record issued in the country of residence/origin certifying the actual illness condition of the patient,
duly translated into English;
b) Declaration of the Italian health care facility, public or private, if private must be accredited with the National
Health Service, specifying type of treatment, start date of the treatment, duration and estimated cost;
c) certificate issued by the Italian health facility confirming the patient has provided a 30% deposit of the
estimated cost for the healthcare requested
Flight reservation or flight ticket including return flight.
Supporting documentation proving the applicant has sufficient financial resources to cover the outstanding
amounts for healthcare, food and lodging outside the health facility, insurance coverage and repatriation of the
patient and their accompanying person:
- Salary certificate, stating: employment status, monthly salary/annual income, position, starting date of the
employment, name, position and contact details of the person signing the no objection letter must be clearly
written.
- Bank statements for the last six months, no older than 1 week in original or photocopy with original bank stamp
(on-line statements are not accepted)
For MINOR/UNEMPLOYED/HOUSE WIFE/STUDENT applicants:

**Declaration of financial support** (available at the "Download Forms" link) signed by the person who is sponsoring, with the required attachments: sponsor ID/passport photocopy, bank statements and letter from the sponsor's employer as described above.

FOR MINOR applicants:

**Parental authorization** (available at the "Download Forms" link) signed by both parents (legal guardian) authorizing the minor to travel and a photocopy of parents' passports.

If one of the parents is abroad, he/she need to contact the Visa Section of the Embassy by email: <u>visti.mascate@esteri.it</u>

A legalized birth certificate, in original or a certified copy, translated into English or Italian, must be provided. A birth certificate is not required if the names of both parents or legal guardians are present in the passport of the minor concerned.

## DECLARATION:

- an application without a complete set of documents according to the present Tourist Visa checklist may lead to the refusal of my visa application;

- the submission of a complete file does not guarantee the issuance of a visa;
- the Embassy of Italy in Muscat reserves the right to ask for additional documents and personal interview;
- once the application is submitted the passport cannot be withdrawn.
