

TEMPORARY VISA FOR FOREIGN NATIONAL OF JAPANESE SPOUSE (INCLUDING MULTI VISA)

1. Eligible Applicants

A spouse of foreign national who is legally married to a Japanese national who resides or works in Myanmar for a long term legally

- **Single, Double visa**

- ☐ The applicant needs to be living with his/her Japanese spouse

- **Multiple visa**

- ☐ The applicant needs to be living with his/her Japanese Spouse

- ☐ The applicant needs to have entered Japan more than once

- ☐ Marriage period must be more than one year

The special adopted children (excluding adopted children) of Japanese nationals legally residing or working in Myanmar for a long term, or those born as children of such Japanese nationals, are also eligible for this visa. For more details, please contact our consular staff by phone or e-mail.

<u>Notes</u>
Arrange your documents in the order according to the checklist.
All documents should be printed or photocopied on A4-sized paper.
Separate all the application documents into individual sets. Family should separately prepare documents arranged in the same order. Remove all staple / pins / paper clips used on the documents
Submit photocopies of documents as specified in our requirements, submitted documents would NOT be returned.
Document must be issued within 3 months of the lodgement of visa application. Any document issued before 3 month from the date of lodgement of visa application, will not be accepted.
All Myanmar documents should be submitted in original with Japanese or English translation and photocopy for each document.
As for the documents which are not mentioned specifically, please submit one set of original ones.
