Documents Required for Visa Applicants submitted by Travel Agencies

In addition to the documents required for each individual application, the following additional documents must be submitted by the travel agency for each visa application on behalf of the applicant.

Important Notes:

- Only travel agencies that provide travel services, and whose applicants are required to use the services planned by the agency, are eligible to apply on behalf of the applicants. Additionally, the travel agency applying on behalf of the applicant must guarantee that the applicant will travel according to the submitted itinerary
- Attach the additional documents listed below at the back of the visa application. If there are multiple applications, attach them only to the first one.
- Travel agencies should submit the documents only after the documents have been reviewed and approved by the applicant.

(If the proxy is a new employee or an existing employee visiting the visa center for the first time, a newly issued company letter is required) • This proxy must be a full-time employee of the said travel agency above submitting the application. (Dispatchers or non-staff that come to the counter only to drop off applications are not allowed.)

	Original Applicant's List from the previous month, photocopies of each applicant's passport biodata page and photocopies of passport pages showing Japanese entry and exit stamps for each listed traveler.
	•Applicant's List Submit 2 copies of the list. Ensure that the details of all applicants who were scheduled to travel in the previous month under the same proxy application are clearly stated. Please note that the reporting period covers individuals who declared on the application list that the intended date to depart Japan is between the 26th of the month before last and the 25th of the previous month. (For example, the applicant's list to be submitted in December must be for applicants who declared on the application list that they intend to depart from Japan between October 26 and November 25.)
	•Passport Biodata Page and Japanese Entry/Exit Stamps (1 set for each applicant) Submit photocopies of the passport biodata page and pages showing Japanese entry/exit stamps. If there is no exit stamp, submission is not required.

	Business Registration Profile from ACRA and Company letter
	 Submit 2 sets for each document stated above. Business Registration Profile from ACRA with the company's principal activity clearly stated as "Travel Agencies and Tour Operators". Company Letter Proxy's name, Nationality, Date of Birth and Employment start date must be stated. The company letter must include a statement certifying that the information provided is accurate and must be signed by an authorized company representative.

	•The package tours and travel services provided by the company should be clearly stated on the company's website or in brochures (and etc.) accessible to the general public.
