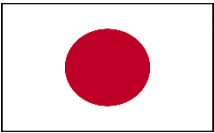


CHECKLIST FOR WORKING AND LONG STAYS VISA

This is for the Purpose of Employment, Residency, Activities to receive remuneration of staying more than 90 days etc.

1.	<input type="checkbox"/>	Application Form <ul style="list-style-type: none">Completed Visa application Form.Nationals of Russian, CIS countries or Georgia are required 2 sets of visa application form.
2.	<input type="checkbox"/>	Photos <ul style="list-style-type: none">Must be a clear copy, high-resolution, white background and recent photo (not older than 6 months).Nationals of Russian, CIS countries or Georgia are required 2 photos.
3.	<input type="checkbox"/>	Original Passport. <ul style="list-style-type: none">The ORIGINAL and COPY of PASSPORT with the UAE residence visa must be submitted at the time of application.It must have more than 2 blank visa pages.
4.	<input type="checkbox"/>	UAE Visa Copy <ul style="list-style-type: none">Copy of UAE residence visa (or copy of Emirates ID)
5.	<input type="checkbox"/>	Certificate of Eligibility <ul style="list-style-type: none">It is necessary to obtain the "Certificate of Eligibility" and for you to file a visa applicationOriginal, Copy, or Online Certificate of Eligibility.To obtain the Certificate of Eligibility, an inviting person in Japan should make an application with the nearest Regional Immigration Bureau of the Ministry of Justice to the inviting person's place of residence in Japan (an application for Certificate of Eligibility cannot be made at the Ministry of Foreign Affairs of Japan)

IMPORTANT NOTES:

- The following nationals and residents are eligible to apply for this visa category - UAE nationals and other nationals with residential status in the Emirates of Dubai, Sharjah, Ajman, Umm Al Quwain, Ras Al Khaimah and Fujairah. And the residents of Iraq, Afghanistan, Syria and Yemen.
- **The Consulate reserves the right to request additional documents to substantiate the application.**
- Permit applications must be applied “**In-person**” by the applicant **ONLY**.
- The Certificate of Eligibility does NOT guarantee the entry of Japan. In case you do not fulfill other criteria for landing, the landing permission would be denied by the authority.
- Certificate of Eligibility should be submitted to an Immigration Inspector along with entry visa for landing permission at the port of entry and shall cease to be valid if the application for landing permission is not filed within 3 months from the date of issue.

Please **NOTE** that submitting **INCOMPLETE/INCORRECT** documents that are not meeting the requirements mentioned in the list above or that were advised to you at the counter by the submission officer would lead to **IMMEDIATE REJECTION OR TERMINATION** of the application by the Consulate.
