The minimum coverage of 30,000 EUR including the costs of urgent medical attention and/or emergency hospital treatment in case of an illness as well as repatriation in the event of death.						
5	Flight reservation or other proof of intended transport – reservation for return flight or supporting documents for other means of travel with itinerary						
6	Confirmed hotel reservation - travel company vouchers will not be considered valid						
7	Itinerary plan, if applicant intends to visit more then one Member state						
8	 Proof of sufficient financial means: Original bank letter confirming the balance of the account and bank account statement showing the movements during the last three months, duly stamped and signed by the bank with bank certificate; Proof of regular income e.g. salary pay slips for the last three months (or similar). If the applicant is sponsored – copy of declaration of sponsorship certified by public notary. If family members are sponsored (spouse, children, parents), the sponsor writes a free-form application. Conformation that the sponsor has sufficient finances. For Latvia - no less than EUR 14 for each day of stay, if the duration of the intended stay does not exceed 30 days; not less than EUR 740 (the minimum monthly wage in Latvia), if the duration of the intended stay exceeds 30 days; For Slovenia - the extent of sufficient financial means for each day of stay in Slovenia is 70 euros. For Estonia - the extent of sufficient financial means for each day of stay in Estonia is 70 euros.
