<ul style="list-style-type: none"> <li>Fully completed and signed Long Stay Visa Application Form of the Republic of Latvia: <a href="https://epak.pmlp.gov.lv/NVIS.EService001.WebSite/">https://epak.pmlp.gov.lv/NVIS.EService001.WebSite/</a></li> </ul>		
<ul style="list-style-type: none"> <li>Two recent passport size photographs (Not older than 3 months, size: 3,5 - 4,5 cm, white background and neutral expression necessary, no head or face covering acceptable except for religious reasons; please do not staple).</li> </ul>		
<ul style="list-style-type: none"> <li>Original passport with Kuwait residence permit and the Kuwait ID card, all valid for at least three months longer than the intended stay. The passport must have been issued within the last 10 years, must be in a good shape and have at least 2 empty pages. The applicant needs to provide a photocopy of the identity page of the passport, the Kuwait residence permit and any previous Schengen visas from the last 3 years.</li> </ul>		
<ul style="list-style-type: none"> <li>An invitation by applicant's education facility in Latvia that is approved by the Office of Citizenship and Migration Affairs of Latvia (OCMA/PMLP) has to be submitted. The invitation should be dated not later than 6 months prior to the application date. Since the OCMA/PMLP does not issue an official confirmation letter about the formed invitation then the applicant can present the invitation number in any form, for example, printed e-mail.</li> </ul>		
<ul style="list-style-type: none"> <li>Letter from your University in Latvia about full time studies in Latvia and that you have been matriculated in the University.</li> </ul>		
<ul style="list-style-type: none"> <li>A copy of a signed study agreement has to be submitted along with the documents.</li> </ul>		
<ul style="list-style-type: none"> <li>A copy of a proof of your intended residence in Latvia has to be submitted along with the documents.</li> </ul>		
<ul style="list-style-type: none"> <li>Original bank account statement showing the movements during the last three months with balance confirmation letter from the bank duly stamped and signed by the bank.</li> </ul>		
<ul style="list-style-type: none"> <li>In case you are sponsored by a family/relative, a notarized declaration of sponsorship to be submitted. Proof of professional status of the sponsor – contract of employment, pay slips for the last 3 months, bank statement of the last 3 months; self-employed – certificate of registration of the Company.</li> </ul>		
<ul style="list-style-type: none"> <li>Originals presented and copies of your prior education diplomas and marksheets have to be submitted (original documents should be legalized at the Embassy of Latvia in the UAE).</li> </ul>		
<ul style="list-style-type: none"> <li>Flight ticket reservation.</li> </ul>		
<ul style="list-style-type: none"> <li>Travel insurance certificate valid for 90 days. The minimum coverage of 42,600 EUR including the costs of urgent medical attention and/or emergency hospital treatment in case of an illness as well as repatriation in the event of death. Medical insurance policy can be obtained in applicant's country of residence, or in any other country, or taken out by the inviting person. It is important that the insurance meets all the above requirements.</li> </ul>		
<ul style="list-style-type: none"> <li>Visa fee – 90 EUR + VFS Global fees</li> </ul>
