Conditions for Visa

Conditions of the application to be applied as per the clauses below:

Clause -A

Tourist Visa:

- (1) Visa application form to be filled properly as per Embassy instructions.
- (2) Color Photocopy of the passport of the applicant with the validity of minimum 6 months at the time of submission of the application.
- (3) Two latest clear photographs of the applicant.
- (4) Hotel reservation with the name of the applicant or 'invitation letter' from the Lebanese counterpart with clear address details in Lebanon. If the invitee is Lebanese then there must be a copy of his Id proof. And if the invitee is foreigner then there must be a 'residential permit card' of Lebanon with the validity of minimum 3 months.
- (5) Prior Air ticket booking for arrival and departure.
- (6) Latest 'Bank Statement' of at least 3 months having the amount of 5 Lac minimum or proof of sufficient financial records to bear the expenditures of stay in Lebanon.
- (7) Covering letter (one's complete introduction.)
- (8) Dependent applicants (wife, son, daughter, mother) follow the applicant regarding Articles 6, 7 of 'Clause A'.
- (9) Foreigners living in Lebanon inviting Indians should have the 'residential permit card' with the validity of more than 6 months.

Clause -B

Business Visa:

- \triangleright The applicant will follow all the prescribed conditions of the 'Clause A'.
- ➤ Invitation done at a notary public by the Lebanese counterpart with clear address details in Lebanon mentioning the invited person's name and proposed stay.
- Registration certificate of the company (in Lebanon).
- > Proof of business relations with the Lebanese company (contracts....)

Clause - C

Visa for family visit:

- \triangleright The applicant will follow all the prescribed conditions of the 'Clause A'.
- Documents that prove the family relationship (Marriage or Birth Certificate or individual Id.)

Clause -D

Visa for medical treatment:

- \triangleright The applicant will follow all the prescribed conditions of the 'Clause A'.
- Medical report of the patient.
- Certificate from the treating doctor that may fixe the duration of the treatment and the stay.

Clause -E

Visa for conference or training:

- \triangleright The applicant will follow all the prescribed conditions of the 'Clause A'.
- Arabic invitation letter from the sponsor institution, university, or organization that could highlight the program of the conference or training and the duration of stay.

Clause -F

Transit Visa:

- ➤ Visa of the country where the applicant is going to travel or the 'residential permit card of that country is required.
- Air ticket for the country where the travel is to be desired.

Clause - G

Visa for study purpose:

- Admission letter for study issued by the university, school or institution recognized by the Lebanese Govt. or invitation letter from either institutions must be in Arabic, addressed to the Embassy.
- Financial records proving that the applicant can sustain his living in Lebanon.
- ➤ The applicant who has a scholarship, may be exempted from submitting the admission letter or financial records to pursue study, but he / she has to attach the admission letter with scholarship.

Duration of visa enquiry:

The applicant will submit the application before minimum 15 days of his travelling and visa status might be enquired within 20 days.
