1.	One (1) completed and signed visa application form duly filled in legibly in English. 用英文清晰字母填写的一份完整的并已经签字的签证申请表			
2.	Valid passport with at least 6 months remaining from the date of departure from China and the passport is to be valid for a minimum of three months after expiry of the visa. It should contain at least 2 blank pages. 护照从中国离境日期后至少有 6 个月有效期且保证护照有效期长于签证有效期 3 个月，同时护照至少保留 2 页空白签证页			
3.	Original and one (1) photocopy of passport (empty pages need not be photocopied). 护照原件及一份印件（空白页不需要复印）			
4.	Two (2) passport-size photographs bearing a true likeness to the applicant. 两张白底证件照规格的近照			
5.	One (1) copy of the ID card. 一份身份证复印件			
6.	One (1) copy of the family book. 户口本一份全本复印件。（只针对中国公民）			
7.	A confirmed two-way air ticket reservation issued by an airline or authorized travel agency. The ticket should only be bought after the visa has been issued. When applying for a multiple-entry visa please provide the reservation for the first entry. 往返机票订单，可以来自航空公司或者旅行社。申请人应于签证签发后，出票付款。若申请多次入境签证，需提供首次行程的往返机票订单。			
8.	Proof of Accommodation in Malta 马耳他的住宿证明			
9.	Proof of a valid travel insurance policy, either individual or group, with a minimum cover of 30,000 Euro and must be valid in Schengen country. 人身意外医疗旅游保险，个人及团体都要求最低保额在 3 万欧元以上，申根国家有效。			

10.	Proof of Employment in Malta: Original letter from employer indicating name, address, telephone number of the employer, position of applicant, tenure duration, salary. 马耳他雇主出示的邀请函原件，包括雇主的姓名，地址，电话号码，申请人的职位，任期，薪金			
11.	Employment License as issued by the Employment and Training Corporation (ETC) in Malta <u>Or</u> Acceptance letter for a Single Permit for Residence and Work issued by the Department of Citizenship & Expatriate Affairs in Malta 马耳他就业及培顺公司 (ETC) 颁发的雇佣许可 <u>或</u> 马耳他公民及侨民事务署签发的居住和工作单次许可函			
12.	Notarized non-criminal certificate 无犯罪记录公证			
13.	Notarized Occupational Certificate, if available. 被公证的职业资格证书（如果有的话）
