1.	One (1) completed and signed visa application form duly filled in legibly in English. 用英文清晰填写的一份完整的并签字的签证申请表			
2.	Valid passport with at least 6 months remaining from the date of departure from China and the passport is to be valid for a minimum of three months after expiry of the visa. It should contain at least 2 blank pages. 护照从中国离境日期后至少有 6 个月有效期且保证护照有效期长于签证有效期 3 个月，同时护照至少保留 2 页空白签证页			
3.	Original and one (1) photocopy of passport (empty pages need not be photocopied). 护照原件及一份复印件（空白页不需要复印）			
4.	Two (2) passport-size photographs bearing a true likeness to the applicant. 两张护照尺寸的近照			
5.	One (1) copy of the ID card. 一份身份证复印件			
6.	One (1) copy of the family book with every page included. 户口本一份全本复印件。（只针对中国公民）			
7.	A confirmed flight reservation issued by an airline or authorized travel agency. The ticket should only be bought after the visa has been issued. 机票订单, 可以来自航空公司或者旅行社。申请人应于签证签发后出票付款。若申请多次入境签证，需提供首次行程的往返机票订单。			
8.	Proof of accommodation for the whole duration of the intended stay. 整个行程的住宿证明。			

9.	Proof of a valid travel insurance policy, either individual or group, with a minimum cover of 30,000 Euro and must be valid in Schengen country. 有效的人身意外医疗旅游保险，个人及团体都要求最低保额在3万欧元以上，且须在申根国家有效。			
10.	Invitation Letter / Statement from EU/EEA/Swiss family member. 邀请函 来自欧盟地区/EEA 地区/瑞士家庭的邀请函或陈述函。			
11.	Copy of ID Card or Passport of EU/EEA/Swiss Family Member 配偶的身份证或者护照的复印件 来自欧盟地区/EEA 地区/瑞士家庭成员的身份证或护照的复印件。			
12.	Original proof of relationship with EU/EEA/Swiss national (e.g. marriage certificate, birth certificate, etc.) issued and legalized by a competent authority. 由权威机构签发的与欧盟地区/EEA 地区/瑞士籍人士的关系公证证明（例如：结婚证，出生证等）。			<p>If the proof of relationship document is issued by the Maltese Public Registry then only a copy of the document is needed. 若关系证明文件是由马耳他公共注册处签发。</p> <p>Where the document is not in English, a translation in English is to be provided. 只须提供文件的复印件，若文件不是英文版，则需提供英文翻译。</p>

The applicant is hereby informed that submitting the above-mentioned documents does not guarantee the automatic issuance of a visa. It is also important to note that original certificates submitted with applications may not in all cases be returned.
