One recent passport photo according to ICAO standard, white background; must be recent (not older than 8 months)		
Original passport and copy of Valid Travel Document ( should be valid for at least 8 months )		
Confirmed Accommodation Reservation		
Confirmed air ticket/s. If ticket is presented, a copy is retained.		
Health Insurance acceptable in the Schengen Area (minimum coverage has to be 30,000 Euros) and which should cover the period of validity of visa.

Proof of Employment in Malta: Letter from employer indicating name, address, telephone number of the employer, position of applicant, tenure duration, salary.		
Employment License as issued by Jobsplus in Malta or Work Permit Letter (Approval in Principle) issued by Identity Malta Agency, which should not be more than 180 days from the date of issue. If the letter is more than 180 days, the applicant cannot apply and the employer should request another letter from the Maltese Authorities. Expired Approval in Principle Letters will not be accepted.		
Proof of Accommodation in Malta/ Declaration of Proof form, duly notarized along with copy of the ID card of the host.		
Applicants with an Employment License to work as drivers (of any type) must provide a copy of their driving license in the country of residence or International Driving License.

Original Letter of Acceptance by the Maltese Education Institution including details of the course, duration and fees with proof of payment.		
Proof of sufficient and regular personal financial means (Original bank statement for the past 6 months). If the sponsor will cover the expenses, original bank statement for 6 months should be presented along with the guarantee letter and passport copy.		
Proof of Employment: Those in full time gainful employment should submit a letter from the employer indicating name, address, telephone number of your employer, position of applicant, tenure duration, salary and confirmation that the applicant will resume duties on his return.		
Those in full-time education should submit a letter from their education establishment clearly indicating the course of studies being followed.		
Proof of Accommodation in Malta/ Declaration of Proof form, duly notarized.
