

Visa Requirements for Application of D Visa – Malta Only

- 1. Completed Visa Application Form
- 2. One recent passport sized colour photos with white background in electronic format
- 3. Copy of the Valid Travel Document, the period of validity of which should exceed that of the visa by three months.
- 4. Confirmed Flight Booking (stamped and signed by travel agent) or copy of actual flight ticket showing full itinerary of your trip.
- 5. Confirmed Hotel Reservation
- 6. Health Insurance acceptable in the Schengen Area (minimum coverage has to be 30,000 Euros) and which should cover the period of validity of visa.
- 7. For Minors (Under the Age of 18): Birth Certification of Minor, Authorization by both Parents / Legal Guardians, Copy of Passport Data page of both Parent / legal guardian, In Case of guardianship, documentary evidence proving the status.

In addition to the above mentioned documents, please provide the below mentioned documents if you are travelling for:

1. Family Reunification of Non –EEA National:

- a) Letter from the Department of Citizenship and Expatriate Affairs in Malta confirming family reunification rights.
- b) Copy of Maltese Residence permit and the passport copy.

2. Study in Malta – duration more than 90 days:

- a) Original Letter of Acceptance by a the Maltese Education Institution including details of the course, duration and fees with proof of payment.
- b) Proof of sufficient and regular personal financial means (Original bank statement for the past 6 months). If the sponsor will cover the expenses, original bank statement for 6 months should be presented along with the guarantee letter and passport copy.
- c) Proof of Employment: Those in full time gainful employment should submit a letter from the employer indicating name, address, telephone number of your employer, position of applicant, tenure duration, salary and confirmation that the applicant will resume duties on his return.
- d) Those in full-time education should submit a letter from their education establishment clearly indicating the course of studies being followed.
- e) Letter from the Institute undertaking the return of student to the country of residence upon completion of the study.

3. Working in Malta:

- a) Proof of Employment in Malta: Letter from Employer indicating, position of the applicant, his tenure duration, salary, place of residence in Malta.
- b) Employment confirmation issued by Citizenship and Expatriate Affairs Department in Malta.
- c) Work Permit Letter issued by the Maltese Authorities and should not be more than 60 days from the date of issue. If the letter is more than 60 days they cannot apply and the employer should request another letter from the Maltese Authorities.

4. Business Visa:

a) Invitation Letter from the organisation in Malta.
