

## Checklist for visa application | Visit to family / friends

Applications should be submitted in person (also babies and children) and the following documents must be submitted:

- For every document, you must provide the original and one copy.
- The documents are to be presented in (or translated to) Dutch, English, French or Spanish.
- The documents submitted will not be returned. Only the travel document will be returned.

1.	Application
1.1	A completed and signed Schengen visa application form.

2.1	A passport or other travel document.

•	Your passport or travel document must be valid for at least 3 months from the date on which you leave the Schengen area.  Your passport or travel document must have at least 2 empty visa pages.  Your passport or travel document cannot have been issued more than 10 years ago.

## 3. Evidence of legal residence

3.1 Evidence of legal residence in the country you are applying from, e.g. a passport, visa or residence permit and a copy or work permit (if applicable). Residence permit should be valid for at least 3 months after departure from Schengen.

	Non-Brazilian nationals residing in Brazil: a residence permit issued by the Brazilian authorities (visa, 'Registro nacional de estrangeiros', 'RNE/Cédula de Identidade de Estrangeiro', 'protocolo' etc.), valid for at least three months after the intended date of departure from the territory of the Member State. 4.	Photo
4.1	A passport photo that meets Dutch passport requirements. This photo cannot have been taken more than 6 months ago and must bear a clear resemblance.  See: <a href="mailto:photo guidelines.">photo guidelines.</a>

5.	Proof of travel
Note: r	make travel reservations which you can cancel, in case your visa request will be refused.
5.1	Ticket reservation for return trip to Brazil or to the country of final destination

5.2	Proof of financial resources in Brazil and proof of integration into the country (for example, proof of employment, property ownership, family ties).
