About the sponsorship

What being a sponsor means

A person who is going to visit Norway must show that they have enough money for their stay and the return journey. If they do not have enough money themselves (NOK 500 times the number of days in Norway/Schengen), they must have a financial guarantee from the person they will visit. This is a sponsor.

The requirements for you as a sponsor:

- You must be a resident of Norway, and
- You must be over 18 years of age.

What it means to be a sponsor

Being a financial sponsor is not the same as guaranteeing that the person visiting leaves Norway when the visit is over. It is impossible for you to make that type of guarantee.

We are the ones who assess whether it is likely that the person who has applied for a visa will return home when the visit is over based on their links to their home country.

One form per person per visit

If you are going to be a financial sponsor for more than one person, you must submit a separate sponsorship form for each person visiting. This form can only be used for one journey.

If your visitor plans to visit you several times, you must fill in a new sponsorship form for each visit.

Rights and duties

You have certain rights and obligations in relation to the information you provide in this form.

Why do you have to provide information?

We need information about you in order to process the visa application of the person you or the company/organisation you represent will be sponsoring.

Legal basis ^

- We are allowed to process your personal data [according to the visa regulation Article 14 \(4\)](#).
- The collection of information in this form is necessary for the assessment of the visa application of the person for whom I/the company/organisation will be a sponsor and the assessment of whether the entry conditions for this person have been met.

We share information about you with Schengen Member States

Information about you is handled by the Schengen Member States.

You must be aware of and consent to the following: ^

- Collection of the information required by this sponsorship form.
- The information is sent to and stored in the [Visa Information System \(VIS\)](#) for five years. During this period, they are available to the immigration authorities and other administrative bodies that carry out checks at the border to and within the territory of the Schengen member states. They may use the information to verify that the conditions for legal entry to and stay on the territory of the member states are met. [The Directorate of Immigration is the responsible authority for processing the information](#).
- I am aware that I have the right to know what information is registered about me in VIS and which Schengen countries have registered the information.

You have a duty to provide us with correct information

You must provide correct, up-to-date, and complete information to the immigration authorities.

You must be aware of and consent to the following:

- I hereby declare that all the information I have given is correct and complete.
- I know that I can be punished if I give a false statement, according to the Immigration Act § 108 first paragraph letter c and the Criminal Code (2005) § 221.

We keep your personal data safe

Your personal information is stored securely in our systems.

How we handle your personal data

- We store your personal data in our databases.
- The UDI and the other agencies in the immigration administration have access to the information about you that is necessary to process the case of the person you are sponsoring.
- We keep the information for as long as is necessary to be able to carry out our tasks. Your information can then be transferred to the National Archives per the rules in the Archives Act. Started sponsorship forms will be deleted after six weeks of inactivity.

We share information about you with other Norwegian government agencies.

We collect information about you from other authorities. When you provide information, we also share parts of that information with other public authorities.

We collect and share information with the following

- The immigration authorities have a duty of confidentiality. We can only disclose your personal data if it is stated in the law that we can or if you consent to it.
- We are obliged to disclose information to other European countries that cooperate in controlling national borders, visa regulations, and police duties (the Schengen cooperation).
- We can submit your sponsorship declaration to administrative bodies other than the immigration authorities without being hindered by the Public Administration Act's rules on confidentiality.

What are your rights?

When you provide personal information to us, you also have certain rights.

You have the following rights

- I am aware that I have the right to obtain in any of the Member States notification of the data relating to me recorded in the [VIS](#) and of the Member State which transmitted the data, and to request the data relating to me which are inaccurate be corrected and that data relating to me processed unlawfully be deleted.
- **Access:** You have a right to be given information about:
 - what personal data we have registered about you
 - from where these were obtained
 - to what purpose they are being used (tasks)
 - whether they have been disclosed to others and, if so, to who
 - you request access by [contacting us](#).
- **Correction and deletion:** I know that I can ask to have incorrect information about me corrected and information about me that has been stored illegally deleted. On request, the authority that processes the visa application of the person I/the company/organisation will be sponsoring must inform me of how I can access the information registered about me and have it corrected or deleted.
- **Appeal:** If you believe that the UDI does not process your personal data in accordance with the law, you can appeal to [the Norwegian Data Protection Authority](#) (external website).
