Please be informed that a failure to submit the documents listed below **may result in visa refusal by the Embassy/Consulate General of the Republic of Poland**. The required documents have to be translated into Polish or English in a separate document according to the instructions below. The passport remains at the Embassy/Consulate during the review of the documents.

Visa application form completed in Latin alphabet and signed by the applicant (in case of a minor signed by both parents or legal guardians, if one parent is absent, please refer to the point 11). <u>One color photograph</u> (white background, 35 mm x 45 mm, not older than 6 months, no retouch). 签证申请表 ，无空项，由申请人以拉丁字母签名（未成年人由父母或法定监护人签名）。 <u>一张彩色照片</u> （白色背景，35 毫米 x 45 毫米，拍摄时间不早于 6 个月）。			
2.	Passport or other travel document and one copy of the identification page, copy of the pages with Schengen/Polish national visas (if issued) and copy of page with signature on the passport. If the visas were in the previous passport – copy of that passport identification page and a page with signature. Travel medical insurance covering the entire duration of stay: a) for Schengen visas – an insurance of choice with a minimum coverage of 30 000 EUR and valid in all Schengen states, including costs of emergency treatment, repatriation for medical reasons as well as transportation in case of death. Handwritten certificates will not be accepted. The name of the insured should be also written in Latin alphabet.;
