Please be informed that a failure to submit the documents listed below **may result in visa refusal by the Embassy/Consulate General of the Republic of Poland**. The required documents have to be translated into Polish or English in a separate document according to the instructions below. The passport remains at the Embassy/Consulate during the review of the documents.

1.	<b>Visa application form</b> completed in Latin alphabet and signed by the applicant (in case of a minor signed by both parents or legal guardians, if one parent is absent, please refer to the point 11). <u>One color photograph</u> (white background, 35 mm x 45 mm, not older than 6 months, no retouch). <b>签证申请表</b> ，无空项，由申请人以拉丁字母签名（未成年人由父母或法定监护人签名）。 <u>一张彩色照片</u> （白色背景，35 毫米 x 45 毫米，拍摄时间不早于 6 个月）。			
2.	<b>Passport or other travel document</b> and one copy of the identification page, copy of the pages with Schengen/Polish national visas (if issued) and a copy of page with signature on the passport. If the visas were in the previous passport – copy of that passport identification page and page with signature. Travel document must be: not older than 10 years, valid for at least 90 days after the planned departure date from Poland and containing at least 2 blank pages. <b>护照或其他旅行证件</b> ，附个人信息页复印件及签名页复印件。如有已签发的申根/波兰国别签证，则附其复印件。若已签发的签证在旧护照上，则除旧护照上的签证复印件外，还需提供此护照的个人信息页及签名页复印件。 旅行证件须：不超过10年，有效期至少为签证到期后90天，至少包含2页空白页。			
3.	<b>Travel medical insurance</b> – any insurance listed in the List of accepted insurers, available to download from: <a href="https://www.gov.pl/web/diplomacy/visas">https://www.gov.pl/web/diplomacy/visas</a> <b>旅行医疗保险</b> ：必须是波兰外交部所发布的医疗保险表格中的一项保险；表格请见： <a href="https://www.gov.pl/web/diplomacy/visas">https://www.gov.pl/web/diplomacy/visas</a> 。			
4.	<b>Original and valid certificate of the institution conducting the studies on admission to studies or on continuation of studies.</b> This document must contain information about the current year of study and semester, <b>not older than 3 months.</b>

5.	<b>Proof of appropriate accommodation for the intended period of stay:</b> 1. Certificate of registration ( <i>zameldowanie</i> ) 2. Lease agreement, 3. Decision on the provision of the dormitory issued by the unit conducting the studies, 4. Other lending contract. Documents shall contain information about the cost of living. <b>预计逗留期间的适当住宿证明</b> 1. 登记证书 ( <i>zameldowanie</i> ) 。 2. 租赁协议。 3. 提供宿舍的决议。 4. 其他租赁合同。 文件应包含有关住宿费用的信息。			
6.	<b>Flight Reservation</b> (reservation only) <b>机票预订单</b> (仅需预订单) 。			
7.	<b>Proof of highest completed level of education:</b> For applicants starting the first year of studies/preparatory course: <b>secondary school certificate or diploma notarized and legalized by the MFA.</b> For applicants starting the second and third cycle studies: <b>diploma of graduation notarized and legalized by the MFA.</b> <b>获得的最高教育水平的证明。</b> 对于开始第一年学习/预科课程的申请人：经外交部认证的中学毕业证书或文凭。 对于开始第二和第三阶段学习的申请人：由外交部颁发的证书或经外交部认证的毕业证书。			
8.	<b>Proof of proficiency (B2 or higher) in language of instruction</b> (internationally accepted certificate or a degree previously obtained in this language). <b>教学语言的熟练程度 (B2 或更高) 证明 (国际认可的证书或以前用该语言获得的学位) 。</b>			
9.	If not otherwise stated in international agreements – <b>information issued by the Director General of the Polish National Agency for Academic Exchange on the eligibility to receive higher education in Poland</b> (not applicable for holders of high school / university diplomas issued in the PRC). <b>波兰国家学术交流局 (NAWA) 局长出具的在波兰接受高等教育的资格证明 (如果国际协议中没有其他规定——即不适用于中国颁发的高中/大学文凭持有者) 。</b>			
10.	<b>Proof of payment for studies/proof of receiving a scholarship</b> (if applicable) – issued by a scholarship providing institution. <b>学习费用支付证明/获得奖学金的证明 (如适用) --由进行学习的单位出具。</b>			
11.	<b>Minors travelling alone or with one parent:</b> 1. Notarized birth certificate legalized by the MFA (if the minor is not in the parent's hukou), 2. If the minor travels only with one of the parents, notarized certificate of permission to travel from the other parent (legalized by MFA if drafted in China, if notarized by a Polish public notary, no need for legalization), 3. If the minor travels with a third person (not parents), notarized certificate of permission to travel from both parents needs to be legalized by MFA and consulate or embassy, 4. Notarized death certificate in case of death of a parent, 5. In case the parents are divorced and one of the parents lost custody of the child – notarized court verdict legalized by MFA.

12.	<p><b>Proof of financial means</b> (one of the following documents):</p> <ol style="list-style-type: none"> <li>1. Traveler's cheques,</li> <li>2. Certificate of the credit card limit issued by the bank (any bank located in China or Poland or another country is allowed),</li> <li>3. Certificate of availability of money in a Polish or European Union bank or a cooperative savings and loan association located in Poland or European Union (certificates of Chinese banks are not accepted),</li> <li>4. Document confirming the grant of a national or foreign scholarship,</li> <li>5. Certificate of employment with monthly salary statement.</li> </ol> <p>Documents stated in point 2, 3 and 5 shall not be issued more than one month before submission of visa application.</p> <p><b>Minors and adults financially dependent on their parents (if applicable)</b></p> <p>Notarized sponsor's letter from parents, as well as documents confirming the availability of financial means (points 1-5). The letter should state that parents are willing to cover all travel and accommodation expenses of the applicant. If the applicant's parents are not indicated in the applicant's <i>hukou</i>, the applicant must submit a notarial certificate on family ties in Chinese with a translation into Polish or English, legalized by the MFA.</p> <p>Sponsorship by a third person is possible only after obtaining approval from the consul – the sponsor's letter must be certified by a notary and legalized by Chinese MFA.</p> <p><b>Supplementary materials:</b></p> <ul style="list-style-type: none"> <li>• Certificates from parents' workplaces, duly signed and stamped, with a specification of monthly remuneration.</li> <li>• If the parents are retired, proof of retirement or other regular income is required.</li> <li>• Documents confirming the possession of another source of family income (e.g. from commercial activities, renting an apartment) must be proved by providing relevant certificates as well as proof of payment of tax.</li> </ul> <p><b>经济能力证明（以下文件之一）。</b></p> <ol style="list-style-type: none"> <li>1. 旅行者的支票。</li> <li>2. 银行出具的信用卡额度证明（任何位于中国或波兰或其他国家的银行都可以）。</li> <li>3. 波兰或欧盟银行或位于波兰共和国或欧盟境内的合作储蓄和贷款协会的资金可用证明（不接受中国银行的证明）。</li> <li>4. 证实获得国家或外国奖学金的文件。</li> <li>5. 带有月工资单的就业证明。</li> </ol> <p>第 2、3、5 点所述的文件不得在提交签证申请前一个月内签发。</p> <p><b>未成年人在经济上依赖父母的成年人（如适用）</b></p> <p>经公证的父母担保信，以及确认有经济来源的文件（第 1-5 点）。信中应说明，父母需承担申请人的所有旅行和住宿费用。如果申请人的父母没有在申请人的户口本上注明，申请人必须提交经外交部认证的中文家庭关系公证书，并翻译成波兰语或英语。</p> <p>只有在获得领事的批准后才可由第三人担保 - 担保人的信函必须由公证处公证并由中国外交部认证。</p>			

	<b>补充材料。</b> - 父母工作单位的证明，要有正式的签名和盖章，并注明月薪。 - 如果父母是退休人员，需要提供退休证明或其他固定收入证明。 - 确认拥有其他家庭收入来源的文件（如来自商业活动、租房），必须提供相关证书以及缴税证明。			
13.	<b>Copies of ID and hukou (all the pages – only for Chinese nationals).</b> In case the applicant is from another consular jurisdiction: Zan Zhu Zheng or other police certificate to prove his or her stay in the current jurisdiction. 身份证，户口本所有页的复印件（只针对中国公民） 若申请人来自其他领区，须提供暂住证或其它由公安机关开具的相关证明，证明其在本领区居住。			
14.	<b>Original residence permit with copy</b> (applicable only for non-Chinese passport holders) valid for at least 3 months after the date of application. 居留许可/在中国合法居留的其他证明，以及复印件，有效期至少为提交签证申请之日后 3 个月。			
15.	<b>Additional notes: optional documents.</b> Applicants are allowed to submit additional documents that they consider useful to explain and/or justify the trip. 附加说明：附加文件。 请注意，申请人可以提交能够说明其行程的解释/证明类附加文件。			
16.	<b>For all non-Chinese citizens, when applying for national visas:</b> Non-criminal record, legalized or with an Apostille; 所有非中国公民申请国别签证无犯罪证明（含领事认证或海牙认证）			

**Note:** The Embassy/Consulate General of the Republic of Poland reserves **the right to request additional information/documentation** and, if deemed necessary, to **interview the applicant in person**.

The consul is entitled to assess whether the applicant's **knowledge of the language** in which the studies are to take place **will allow him or her to undertake the education**.

**A visa with the annotation "student" can only be obtained by full-time students** or people going to Poland in order to take a **preparatory course** to study at university.
