Please be informed that a failure to submit the documents listed below may result in **visa refusal by the Embassy/Consulate General of the Republic of Poland**. The required documents have to be translated into Polish or English in a separate document according to the instructions below. The passport remains at the Embassy/Consulate during the entire application period.

1.	<b>Visa application form</b> without blanks, signed by the applicant in Latin alphabet (in case of a minor, signed by both parents or legal guardians), if one parent is absent, please refer to the point 11). <u>One color photograph</u> (white background, 35 mm x 45 mm, not older than 6 months, no retouch). <b>签证申请表</b> ，无空项，由申请人以拉丁字母签名（未成年人由父母双方或法定监护人签名）。 <u>一张彩色照片</u> （白色背景，35 毫米 x 45 毫米，拍摄时间不早于 6 个月）。			
2.	<b>Passport or other travel documents</b> and one copy of the identification page, copy of the pages with Schengen/Polish national visas (if issued) and a copy of page with signature on the passport. If the visas were in the previous passport – copy of that passport identification page and the page with a signature. Travel document must be: not older than 10 years, valid for at least 90 days after the planned departure date from Poland/Schengen and containing at least 2 blank pages. <b>护照或其他旅行证件</b> ，附个人信息页复印件及签名页复印件。如有已签发的申根/波兰国别签证，则附其复印件。若已签发的签证在旧护照上，则除旧护照上的签证复印件外，还需提供此护照的个人信息页及签名页复印件。 旅行证件须：不超过10年，有效期至少为签证到期后90天，至少包含2页空白页。			
3.	<b>Travel medical insurance</b> covering the entire duration of stay in Schengen zone with a minimum coverage of 30 000 EUR valid in the whole Schengen zone, including costs of emergency treatment, repatriation for medical reasons as well as transportation in case of death. Handwritten certificates will not be accepted. The name of the insured should be also written in Latin alphabet. The original and the copy shall be provided. <b>医疗保险原件</b> 及复印件。旅行医疗保险需覆盖整个申根地区的逗留时间和全部申根地区，最低保额为 3 万欧元，包括紧急医疗、医疗原因

4.	<b>Original letter of invitation from the host organization</b> , on official paper, signed and stamped, mentioning: 1) purpose and duration of stay, 2) detailed program and itinerary, 3) an indication of the party that will cover the costs of the culture/sport events, 4) indication of lodging during the period of the intended stay. <b>主办方提供的邀请函原件，需使用正式信头纸打印，签字并盖章，并须包含如下信息：</b> 1) 访问的目的和停留时间， 2) 详细的活动计划和行程安排， 3) 与文化/体育活动相关的费用的支付方式及支付单位， 4) 计划在停留期间的住宿证明。			
5.	<b>Proof of accommodation for the whole duration of intended stay</b> (hotel bookings, lease agreement, other lending contracts). Documents shall contain information about the cost of stay. <b>在波兰覆盖全部停留时间的住宿证明原件</b> (酒店预订，租赁协议，其他租借合同)。 以上所述的所有文件都应注明住宿费用。			
6.	<b>Flight Reservation</b> (reservation only) <b>机票预订单</b> （仅需预订单）			
7.	<b>Original note/letter from the Chinese cultural or sports entity</b> , submitted with Polish/English translation, signed and stamped, mentioning: 1) full address and contacts of the organization, 2) the name and position of the countersigning officer, 3) name, position, salary and years of employment (only for professionals), 4) confirmation of participation, 5) entity that will pay for costs of travel and living, 6) copy of business license (and an English or Polish translation). <b>中国文化或体育机构出具的公函/证明原件</b> （附英文或波兰语翻译）需使用正式信头纸，签字并加盖公章，并须明确列出以下信息： 1) 该机构的详细地址和联系方式， 2) 函件签署人的姓名和职务， 3) 申请人姓名、职务、收入和工作年限（仅限体育运动员）， 4) 参加活动确认， 5) 支付旅行和生活费用的单位， 6) 营业执照复印件（附英文或波兰语翻译件）。			
8.	<b>For employees:</b> 1. A sealed copy of the business license of the employing company, 2. A letter from the employer (in English or in Chinese, translated into Polish/English) on official company paper with stamp, signature and date, clearly mentioning: a) Address, telephone and fax numbers of the employing company, b) The name and position in the employing company of the countersigning officer, c) The name of the applicant, position, salary and years of service, d) Approval of absence. <b>For self-employed or freelancers:</b> Documents proving professional activity. <b>For retired persons:</b> Proof of pension or other regular income.			

	<p><b>For unemployed adults:</b>  a) If married: letter of employment and income of the spouse and notarized certificate of marriage, legalized by the MFA.  b) If single/divorced/widow/widower: any other proof of regular income.  <b>For students:</b>  Certificate from the school and a valid student ID card and one copy.  <b>在职人员:</b>  1. 由任职公司出具的公司营业执照复印件并盖章,  2. 由雇主出具的证明信 (英文版, 或中文版附上英文或波兰语翻译), 需使用公司正式的信头纸打印并加盖公章, 签字, 注明日期, 并明确列出以下信息:  1) 任职公司的地址、电话及传真号码,  2) 任职公司签字人的姓名和职务,  3) 申请人姓名、职务、收入及工作年限,  4) 准假证明。  <b>自雇人员或自由职业者:</b>  需提供文件证明他/她的职业。  <b>退休人员:</b>  养老金或其他固定收入证明。  <b>未就业成年人:</b>  1. 已婚者: 经公证处公证, 外交部认证婚姻关系公证书, 配偶的在职证明和收入证明,  2. 单身 / 离异 / 丧偶: 其他固定收入证明  <b>学生:</b>  在读证明, 有效学生证原件及复印件。</p>			
9.	<p><b>Minors travelling alone or with one parent:</b>  1. Notarized birth certificate legalized by the MFA (if the minor is not in the parent's hukou),  2. If the minor travels only with one of the parents, notarized certificate of permission to travel from the other parent (legalized by MFA if drafted in China, if notarized by a Polish public notary, no need for legalization),  3. If the minor travels with a third person (not parents), notarized certificate of permission to travel from both parents needs to be legalized by MFA and consulate or embassy,  4. Notarized death certificate in case of death of a parent,  5. 10.	<p><b>Proof of financial means:</b> Bank statements from the current account from the last 3 months, no deposits.  1. Proof of the solvency of the employing company, if the company pays the costs of travel and living, or  2. Proof of the applicant's personal solvency, in case personally covering the costs of travel and living.  <b>申请人偿付能力证明:</b> 最近 3 个月的银行对账单, 无需存款证明。</p>			

	1. 如果公司支付旅行及生活费用，需提供公司的偿付能力证明，或 2. 如果申请人自行承担旅行及生活费用，需提供申请人个人偿付能力证明。			
11.	<b>Copies of ID and hukou (all the pages – only for Chinese nationals).</b> In case the applicant is from another consular jurisdiction: Zan Zhu Zheng or other police certificate to prove his or her stay in the current jurisdiction. 身份证，户口本所有页的复印件（只针对中国公民） 若申请人来自其他领区，须提供暂住证或其它由公安机关开具的相关证明，证明其在本领区居住。			
12.	<b>Original residence permit/other proof of legal stay in China, with a copy,</b> (applicable to foreigners except Chinese citizens) valid for at least 3 months after the date of submission of visa application. 居留许可/在中国合法居留的其他证明及其复印件（适用于除中国公民外的外国公民）。有效期至少为提交签证申请之日后 3 个月。			
13.	<b>Additional notes: optional documents.</b> Applicants are allowed to submit additional documents that they consider useful to explain and/or justify the trip. 附加说明：附加文件。 请注意，申请人可以提交能够说明其行程的解释/证明类附加文件。
