TEMPORARY STAY VISA FOR REMOTE WORK - "DIGITAL NOMADS" – CPLP MOBILITY AGREEMENT**CPLP citizens are exempt from presenting:**

- Travel insurance;
- Return transport ticket; and
- Means of support, **upon presentation of a sponsorship letter**, with a legalised signature, issued by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay.

**Notes:**

- Failure to submit all the necessary documents may lead to the rejection of the visa application.
- The Consular Post reserves the right to request supplementary documents if necessary.
- Even if all the requested documents are presented, it does not imply the automatic granting of the visa. The visa fee is not refunded if the visa is refused.
