4	Reservation of Return Flight Travel Ticket.		
5	Document certifying the third-country national is in a regular situation when the applicant is from a different nationality than that of the country where the visa is being requested.		
6	Overseas travel medical insurance valid for all Schengen-countries .The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation, loss of baggage, etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival in & departure from India.		
7	Form authorizing access to Portuguese criminal record by the Immigration and Border Services (Servico de Estrangeiros e Fronterias - SEF).		
6	Proof of Accommodation (Hotel/Apartment booking reservations). Please provide a booking reservation directly from Hotel or from any booking sites. Example: booking.com, makemytrip.com, yatra.com etc. Note: Hotel bookings done by any third party travel agent are not acceptable.		
7	Recently issued Police Clearance Certificate issued from Passport Office (not required for minors below sixteen years) in English and duly translated to Portuguese. The documents should be attested with “APOSTILLE” sticker by the Ministry of External Affairs, Consular Division, and Patiala House, New Delhi. <ul style="list-style-type: none"> ➤ PCC In English Language: Apostille ➤ PCC Translated In Portuguese Language : Apostille 		
8	Proof of means of subsistence as stipulated by law.		
9	Proof of subsistence means can be made through a statement of responsibility, signed by a Portuguese national or by a foreign national legally resident in Portugal.		
10	<ul style="list-style-type: none"> • Proof of kinship; • Medical report; • Document issued by the public health establishment or officially recognized health establishment certifying inpatient or outpatient care; • In case of patients traveling under Cooperation Agreements, a document issued by a medical committee and medical appointment must be produced. In such cases, proof of means of subsistence and proof of housing may be replaced by a statement issued by the relevant Embassy in Lisbon to ensure the referred conditions. 		
11	The Passport should be valid for at least three months (any other type of travel document should be valid for at least six months), beyond the intended duration of stay in the Schengen territory and with at least two blank pages to affix the visa. No visa will be issued on the additional page of the passport. <ul style="list-style-type: none"> ○ Copy of the Bio-Pages (First and Last page) of the Passport including the copy of the page stamped by the Passport Office must be enclosed. ○ Copies of all the pages that contain Occidental visas.
