

PORTUGAL CHECKLIST

NATIONAL VISAS – LONG TERM VISAS

Types

Temporary stay visa - is intended to allow entry into Portugal for a period of less than 1 year. It will be valid for the duration of the stay and for multiple entries in Portugal.

Visa to obtain a residence permit - valid for two entries and for four months, during which period the holder must apply to the Aliens and Borders Service for a residence permit.

<p>A third-country national that has had a prior admission in Portugal for the purpose of seasonal work, at least once, in the last five years, having respected the requirements set by law regarding entry and stay in Portugal, will benefit from a simplified procedure for the delivery of a temporary stay visa for seasonal work purposes. Namely, the referred third-country national is exempt from producing documents referred in subparagraph c) and e) of paragraph 1 of article 51. A (housing, regulated profession certificate and return ticket). The visa application should be granted priority status for treatment purposes, and the deadline for issuing a decision cannot exceed 15 days.</p>		
<p>Note:</p> <ul style="list-style-type: none"> - Failure to submit all the necessary documents may lead to the rejection of the visa application. - The Consular Post reserves the right to request documents other than those mentioned above whenever it deems convenient. - Even if all the documents necessary for the process are presented, it doesn't imply the automatic granting of the visa. Refusal of the visa application shall not entitle to reimbursement of the visa fee.
