

## PORTUGAL CHECKLIST

### NATIONAL VISAS – LONG TERM VISAS

#### Types

**Temporary stay visa** - is intended to allow entry into Portugal for a period of less than 1 year. It will be valid for the duration of the stay and for multiple entries in Portugal.

**Visa to obtain a residence permit** - valid for two entries and for four months, during which period the holder must apply to the Aliens and Borders Service for a residence permit.

<b>Certificate of criminal record</b> issued by the competent authority of the country of nationality of the applicant or the country of residence for more than one year (not applicable children under 16)		
<b>A request for consultation of the Portuguese criminal registry</b> for the SEF (not applicable children up to 16 years).		
<b>Copy of the return ticket</b> (not applicable when a residence visa is requested)
