<ul> <li>CPLP citizens are exempted from presenting:</li> <li>Travel insurance,</li> <li>Return transport ticket; and,</li> <li>Means of support, upon presentation of a sponsorship letter (AIMA's model 4 form) with a legalised signature, issued by a Portuguese or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay, along with:</li> <li>Certificate of establishment of the subscriber's household;</li> <li>The subscriber's tax return (last year); and</li> <li>Subscriber's bank statement (last 3 months).</li> </ul>
