TEMPORARY STAY VISA FOR REMOTE WORK - "DIGITAL NOMADS" – CPLP MOBILITY AGREEMENT**CPLP citizens are exempt from presenting:**

- Travel insurance;
- Return transport ticket; and
- Means of support, **upon presentation of a sponsorship letter (AIMA's model 4 form)**, with a legalised signature, issued by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay, along with:
 - Certificate of incorporation of the subscriber's household;
 - Subscriber's tax return (last year); and
 - Subscriber's bank statement (last 3 months).
