1	<b>Visa application filled and duly signed by applicant</b> ➤ For minors and incapacitated, forms should be signed by the legal guardian		
2	<b>Two recent passport size photographs</b> ➤ Passport type, recent and in good condition to identify the applicant (1 for this form)		
3	<b>Passport / travel document</b> ➤ Valid for 3 months after the estimated date of return ➤ It is recommended to attach previous passports (if applicable) ➤ 1 copy		
4	<b>Proof of regular situation</b> ➤ In case of residence in a country other than the country of current nationality, which must be valid 3 months after the estimated date of return		
5	<b>Valid travel insurance (original + 1 copy)</b> ➤ Cover expenses that might arise in connection with repatriation for medical reasons, urgent medical attention, emergency hospital treatment or death during stay. A certificate policy is mandatory		
6	<b>Criminal record certificate (*)</b> ➤ Issued by the competent authority of the country of the applicant's nationality or of the country where the applicant has resided for over a year		
7	<b>Request for criminal record enquiry by the Immigration and Border Services (SEF)</b> ➤ Not applicable to minors under the age of sixteen		
8	<b>Copy of the return ticket</b>		
9	<b>Proof of financial resources</b> ➤ Bank statement last 3 months ➤ Proof of means of subsistence can be done through a term of responsibility ( <i>Termo de Responsabilidade</i> ) signed by the workers' reception entity ( <b>must be legalized</b> by a Public Notary)		
10	<b>Document certifying that the transfer</b> ➤ Is occurring within the same company or corporate group, and that the host institution is providing similar services to those provided by the institution from which the third-country national is being transferred; or ➤ Is referring to partners or workers, that have been in that institution for at least one year, based in another state party to the WTO falling under one of the following categories ➤ Partners or workers in a managerial position working as senior staff and perform executive administration tasks, under the guidance of the board of administration; or ➤ Partners or workers with the necessary technical skills to the delivery of the referred activity, research equipment, as well as technical and managerial skills; or ➤ Partners or workers due to get professional training in Portugal		

**PLEASE NOTE: Pointers (\*) all the documents presented must be translated to Portuguese or English language (if applicable) and attested by the Ministry of Foreign Affairs.**

The Embassy of Portugal in Islamabad reserves the right to request further documentation if deemed necessary, may call the applicant for an interview. False or falsified documents, including fake bookings, will lead to the refusal of visa and/or further consequences.
