1	<b>Visa application filled and duly signed by applicant</b> <ul style="list-style-type: none"><li>➤ For minors and incapacitated, forms should be signed by the legal guardian</li></ul>		
2	<b>Two recent passport size photographs</b> <ul style="list-style-type: none"><li>➤ Passport type, recent and in good condition to identify the applicant (1 for this form)</li></ul>		
3	<b>Passport / travel document</b> <ul style="list-style-type: none"><li>➤ Valid for 3 months after the estimated date of return</li><li>➤ It is recommended to attach previous passports (if applicable)</li><li>➤ 1 copy</li></ul>		
4	<b>Proof of regular situation</b> <ul style="list-style-type: none"><li>➤ In case of residence in a country other than the country of current nationality, which must be valid 3 months after the estimated date of return</li></ul>		
5	<b>Valid travel insurance (original + 1 copy)</b> <ul style="list-style-type: none"><li>➤ Cover expenses that might arise in connection with repatriation for medical reasons, urgent medical attention, emergency hospital treatment or death during stay. A certificate policy is mandatory</li></ul>		
6	<b>Criminal record certificate (*)</b> <ul style="list-style-type: none"><li>➤ Issued by the competent authority of the country of the applicant's nationality or of the country where the applicant has resided for over a year</li></ul>		
7	<b>Request for criminal record enquiry by the Immigration and Border Services (SEF)</b> <ul style="list-style-type: none"><li>➤ Not applicable to minors under the age of sixteen</li></ul>		
8	<b>Copy of the return ticket.</b>		
9	<b>Proof of financial resources</b> <ul style="list-style-type: none"><li>➤ Bank statement last 3 months</li><li>➤ Proof of means of subsistence can be done through a term of responsibility (<i>Termo de Responsabilidade</i>) signed by the workers' reception entity (<b>must be legalized</b> by a Public Notary)</li></ul>		
10	<b>Contract or a promise of a Service Contract</b> <ul style="list-style-type: none"><li>➤ In the framework of independent and temporary work activity</li></ul>		
11	<b>Statement issued by the competent institution</b> <ul style="list-style-type: none"><li>➤ To verify compliance with necessary professional requisites, when the referred profession is subject to special qualification in Portugal</li></ul>		

**PLEASE NOTE: Pointers (\*) all the documents presented must be translated to Portuguese or English language (if applicable) and attested by the Ministry of Foreign Affairs.**
