1	<b>Visa application filled and duly signed by applicant</b> <ul style="list-style-type: none"><li>➤ For minors and incapacitated, forms should be signed by the legal guardian</li></ul>		
2	<b>Two recent passport size photographs</b> <ul style="list-style-type: none"><li>➤ Passport type, recent and in good condition to identify the applicant (1 for this form)</li></ul>		
3	<b>Passport / travel document</b> <ul style="list-style-type: none"><li>➤ Valid for 3 months after the estimated date of return</li><li>➤ It is recommended to attach previous passports (if applicable)</li><li>➤ 1 copy</li></ul>		
4	<b>Proof of regular situation</b> <ul style="list-style-type: none"><li>➤ In case of residence in a country other than the country of current nationality, which must be valid 3 months after the estimated date of return</li></ul>		
5	<b>Valid travel insurance (original + 1 copy)</b> <ul style="list-style-type: none"><li>➤ Cover expenses that might arise in connection with repatriation for medical reasons, urgent medical attention, emergency hospital treatment or death during stay. A certificate policy is mandatory</li></ul>		
6	<b>Criminal record certificate (*)</b> <ul style="list-style-type: none"><li>➤ Issued by the competent authority of the country of the applicant's nationality or of the country where the applicant has resided for over a year</li><li>➤ Except for applicants under sixteen</li></ul>		
7	<b>Request for criminal record enquiry by the Immigration and Border Services (SEF)</b> Not applicable to minors under the age of sixteen		
8	<b>Copy of the return ticket</b>		
9	<b>Proof of financial resources</b> <ul style="list-style-type: none"><li>➤ Proof of means of subsistence can be done through a term of responsibility (<i>Termo de Responsabilidade</i>) signed by the workers' reception entity (<b>must be legalized</b> by a Public Notary)</li><li>➤ Presentation of a term of responsibility, signed by a Portuguese citizen or a foreign citizen, with a residence permit in Portugal, which guarantees food and accommodation for the visa applicant, as well as the replacement of removal costs, in case of irregular stay (<b>must be legalized</b> by a Public Notary)</li></ul>		
10	<b>Medical report</b>		
11	<b>Proof issued by an official or officially recognized health establishment</b> <ul style="list-style-type: none"><li>➤ Ensuring hospitalization or the outpatient treatment</li></ul>		
12	<b>Minors (*)</b> <ul style="list-style-type: none"><li>➤ Copy of the minor's birth certificate (enclose original for verification)</li></ul>		
13	<b>Minors or unfit persons (*)</b> <ul style="list-style-type: none"><li>➤ Require a travel authorization by the parents or legal guardian – proof of consent- Parental authorization for the minor to travel and stay in Portugal for the period specified according to the reason for the stay</li><li>➤ Copy of the parents' passports and copy of the parent's identity card</li><li>➤ Copy of the Court order establishing family relationship or guardianship for the purpose of the intended trip (if applicable)</li></ul>		

**PLEASE NOTE: Pointers (\*) all the documents presented must be translated to Portuguese or English language (if applicable) and attested by the Ministry of Foreign Affairs.**

The Embassy of Portugal in Islamabad reserves the right to request further documentation if deemed necessary, may call the applicant for an interview. False or falsified documents, including fake bookings, will lead to the refusal of visa and/or further consequences.

The Embassy cannot be held responsible for any financial losses, nor can the visa fee be refunded in case of a refusal

The presentation of all necessary documents in the visa application may not be construed as an automatic approval of the visa.
