1	<b>Visa application filled and duly signed by applicant</b> <ul style="list-style-type: none"><li>➤ For minors and incapacitated, forms should be signed by the legal guardian</li></ul>		
2	<b>Two recent passport size photographs</b> <ul style="list-style-type: none"><li>➤ Passport type, recent and in good condition to identify the applicant (1 for this form)</li></ul>		
3	<b>Passport / travel document</b> <ul style="list-style-type: none"><li>➤ Valid for 3 months after the estimated date of return</li><li>➤ It is recommended to attach previous passports (if applicable)</li><li>➤ 1 copy</li></ul>		
4	<b>Proof of regular situation</b> <ul style="list-style-type: none"><li>➤ In case of residence in a country other than the country of current nationality, which must be valid 3 months after the estimated date of return</li></ul>		
5	<b>Valid travel insurance (original + 1 copy)</b> <ul style="list-style-type: none"><li>➤ Cover expenses that might arise in connection with repatriation for medical reasons, urgent medical attention, emergency hospital treatment or death during stay. A certificate policy is mandatory</li></ul>		
6	<b>Criminal record certificate (*)</b> <ul style="list-style-type: none"><li>➤ Issued by the competent authority of the country of the applicant's nationality or of the country where the applicant has resided for over a year</li><li>➤ Except for applicants under sixteen</li></ul>		
7	<b>Request for criminal record enquiry by the Immigration and Border Services (SEF)</b> <ul style="list-style-type: none"><li>➤ Not applicable to minors under the age of sixteen</li></ul>		
8	<b>Proof of financial resources</b> <ul style="list-style-type: none"><li>➤ Bank statement last 3 months</li><li>➤ Proof of means of subsistence can be done through a term of responsibility (<i>Termo de Responsabilidade</i>) signed by the workers' reception entity (<b>must be legalized</b> by a Public Notary)</li></ul>		
9	<b>Teaching activity, highly qualified or cultural activity:</b> <ul style="list-style-type: none"><li>➤ Work contract, work promise or service provider contract; <b>or</b></li><li>➤ Invitation letter issued by a higher education institution; or professional training institution; <b>or</b></li><li>➤ Term of responsibility of a company certified under the terms defined by Ordinance of the members of the government responsible for the areas of internal administration and the economy; <b>or</b></li><li>➤ Invitation letter issued by a company or entity that carries out a cultural activity in the national territory recognized by the member of the government responsible for the area of culture as of interest to the country, or as such defined by law; <b>or</b></li><li>➤ Invitation letter issued by a research center</li></ul> <b>High qualified activity exercised by subordinate worker</b> <ul style="list-style-type: none"><li>➤ Valid work contract or work promise, for a minimum period of one year and for a salary of 1,5 times de annual gross salary, or three times de indexed value for social welfare support (IAS) or</li><li>➤ Regulated highly qualified profession: proof that is enabled to exercise that profession in Portugal; or</li><li>➤ <u>Un-regulated profession</u>: proof that holds high professional qualifications, adequate for the referred field of work or sector stipulated in the work contract or the work promise</li></ul>		

**PLEASE NOTE: Pointers (\*) all the documents presented must be translated to Portuguese or English language (if applicable) and attested by the Ministry of Foreign Affairs.**

The Embassy of Portugal in Islamabad reserves the right to request further documentation if deemed necessary, may call the applicant for an interview. False or falsified documents, including fake bookings, will lead to the refusal of visa and/or further consequences.

The Embassy cannot be held responsible for any financial losses, nor can the visa fee be refunded in case of a refusal.

The presentation of all necessary documents in the visa application may not be construed as an automatic approval of the visa.
