5	Valid travel insurance (original + 1 copy) <ul style="list-style-type: none">➤ Cover expenses that might arise in connection with repatriation for medical reasons, urgent medical attention, emergency hospital treatment or death during stay. A certificate policy is mandatory		
7	Criminal record certificate (*) <ul style="list-style-type: none">➤ Issued by the competent authority of the country of the applicant's nationality or of the country where the applicant has resided for over a year➤ Except for applicants under sixteen		
8	Request for criminal record enquiry by the Immigration and Border Services (SEF) <ul style="list-style-type: none">➤ Not applicable to minors under the age of sixteen		
9	Proof of financial resources <ul style="list-style-type: none">➤ Bank statement last 3 months➤ Proof of means of subsistence can be done through a term of responsibility (<i>Termo de Responsabilidade</i>) signed by the workers' reception entity (must be legalized by a Public Notary)		
10	Independent Professional Activity: <ul style="list-style-type: none">➤ Contract or written service provider proposal for liberal professions➤ Declaration issued by competent authorities certifying professional competence for the referred activity (if applicable) For Migrants Entrepreneurs: <ul style="list-style-type: none">➤ Proof that the Investment operations were executed; and➤ Proof of financial means available in Portugal, including those obtain through a financial institution in Portugal, and proof, by any means, of intention to invest in Portuguese territory Startup Visa Program: <ul style="list-style-type: none">➤ Declaration issued by the Agency for Competition and Innovation (IAPMEI), certifying the signing of an incubation contract with a certified incubator
