1	<b>Application form duly completed and signed (For minors and incapacitated, forms should be signed the legal guardian)</b> <ul style="list-style-type: none"> <li>➤ Fully completed in Portuguese or English and signed and dated by the applicant</li> <li>➤ For minors both parents must sign the application form and visit application center for submission</li> </ul>		
2	<b>One recent passport size photograph</b> <ul style="list-style-type: none"> <li>➤ Should not be older than 6 months + (plus) in colour with white background + (plus) 3,5 by 4,5 cm</li> </ul>		
3	<b>Passport / travel document</b> <ul style="list-style-type: none"> <li>➤ Must have a validity of at least 3 months after the intended stay + (plus) be issued within the previous 10 years + (plus) have 2 blank pages. It is recommended to attach previous passports (if applicable)</li> </ul>		
4	<b>Copy of Pakistani identity card (CNIC)</b>		
5	<b>For non-Pakistani Nationals residing in Pakistan</b> <ul style="list-style-type: none"> <li>➤ Proof of legal residence in Pakistan as appropriate (such as long stay visa, and/or residence or work permit) valid for at least 3 months after expiry of the requested visa</li> </ul>		
6	<b>Flight reservation of air ticket</b> <ul style="list-style-type: none"> <li>➤ Return or round trip from Pakistan to Portugal</li> <li>➤ If trips include several stops in the territory of the Member States, reservations of intra-Schengen itinerary (train, flights, car rental)</li> </ul>		
7	<b>Invitation letter bearing the name <i>Termo de Responsabilidade</i> form or a hotel reservation</b> The <i>Termo de Responsabilidade</i> must: <ul style="list-style-type: none"> <li>➤ be <b>original</b>, signed by the host and certified by a public notary in Portugal together with a copy of the host EU identity card or EU passport or residence card</li> <li>➤ If the inviting person (the host) is to cover the applicant's expenses he/she has to provide evidence of possession of sufficient financial resources to cover the intended stay (e.g. last Income Tax Papers – <i>IRS</i> together with either signed and stamped bank statements for the last 3 months or the last 3 payslips)</li> <li>➤ If the host is to cover accommodation he/she has to provide either a copy of a mortgage contract or a rental contract + (plus) a Certificate of Residency issued by the <i>Junta de Freguesia</i> in Portugal</li> </ul> The hotel reservation must be confirmed for the entire stay		
8	<b>Travel medical insurance (original + 1 copy)</b> <ul style="list-style-type: none"> <li>➤ Must cover the entire territory of all Schengen Member States with a minimum coverage of 30.000,00 € (euros) for medical expenses and be valid for the whole period you plan to stay in the Schengen area <b>and</b> cover expenses that might arise in connection with repatriation for medical reasons, urgent medical attention, emergency hospital treatment or death during stay. A certificate policy is mandatory</li> </ul>		
9	<b>Family Registration Certificate (FRC) (*)</b> <ul style="list-style-type: none"> <li>➤ Issued in English by NADRA (Pakistan National Database and Registration Authority)</li> </ul>		
10	<b>Proof of family relationship (*)</b> <ul style="list-style-type: none"> <li>➤ If the applicant is visiting a close relative, proof of family relationship through copy of the Family Registration Certificate (FRC) issued by NADRA (Pakistan National Database and Registration Authority), proof of family relationship through national civil status records</li> <li>➤ If the applicant is the spouse of the intended visited person, marriage certificate (Nikah Nama) and/or Marriage Registration Certificate issued in English, by Union Council of residence, or other proof as applicable for religious minorities</li> </ul>		
11	<b>Proof of financial means (*)</b> <ul style="list-style-type: none"> <li>➤ National Tax Number Certificate (or proof of exemption if applicable); <b>and</b> Federal Board of Revenue acknowledgement of tax returns for the last two fiscal years before the application date</li> <li>➤ or, if one of the above cannot be produced, other proof, supported by documents, of income generating assets or other means of subsistence as applicable</li> </ul>		

12	<b>Bank account statement for the last 6 months</b> ➤ Bank statements showing movements in the last six months, duly signed and stamped by the bank		
13	<b>Employees</b> ➤ Letter addressed to "Embassy of Portugal in Islamabad", dated not later than one month with the company's letterhead stating the approval for leave of absence, specifying the dates of absence, position and salary of the employee, duration of employment, purpose of absence, contact number of employer + <b>(plus)</b> payslips for the last three months before the application date + <b>(plus)</b> copy of the employment contract <b>Company owners or self-employed (*)</b> ➤ Certificate of registration of the company		
14	<b>Civil servants/government employees</b> ➤ Non Objection Certificate (NOC) issued by the Administration/public service employing the applicant stating the dates of the intended visit <b>Retired</b> ➤ Pension statements for the last six months <b>Applicant is a dependent from another applicant (*)</b> ➤ If the proof of family relationship cannot be established by the Family Registration Certificate (FRC), proof of family relationship through national civil status records must be provided <b>Students (*)</b> ➤ Proof of enrolment at university and student's card		
15	<b>Minor (s) travelling with one or none of the parents/legal guardians (*)</b> ➤ Proof of consent by one (if travelling with the other except in case of a single parent having sole duly attested custody or guardianship) or two parents in an affidavit with details of the planned trip and name of sponsors/guardians during the trip ➤ Copy of the non-travelling parent(s) Pakistani identity card(s) (CNIC(s)) and passport(s) ➤ Proof of enrolment at school ➤ Copy of the Court order establishing family relationship or guardianship for the purpose of the intended detailed trip
