**RESIDENCY JOB SEEKER VISA– UP TO 120 DAYS – CPLP MOBILITY AGREEMENT**

**CPLP citizens are exempted from presenting:**

- **Proof of financial resources** equivalent to at least the sum of three guaranteed monthly minimum salary.

**upon presentation of a statement of responsibility in the following terms:**

- a) Presentation of a term of responsibility, with a recognized signature, signed by a Portuguese citizen or a foreign citizen, with a residence permit in Portugal, which guarantees food and accommodation for the visa applicant, as well as the replacement of removal costs, in case of irregular stay. The citizen that subscribes the Statement of Responsibility must have the financial capacity equal to three times the value of the monthly minimum remuneration.



The citizen who signs the Term of Responsibility must have financial resources in the amount of at least three times the value of the guaranteed minimum monthly remuneration.

**Note:**

- Failure to present all necessary documents may result in the visa application being refused.
- The Consular Post has the prerogative to request additional documents when it considers fit to do so.
- The presentation of all necessary documents in the visa application may not be construed as an automatic approval of the visa. The refusal of the visa request does not entail the reimbursement of the visa fees.
- The job search visa does not foresee the possibility of family members to request the visa for accompanying family member.
