<b>CPLP citizens are exempt from presenting:</b> <ul style="list-style-type: none"> <li>• Travel insurance,</li> <li>• Return transport ticket; and,</li> <li>• Means of support, <b>upon presentation of a sponsorship letter in the following terms:</b> <ol style="list-style-type: none"> <li>a) Presentation of a sponsorship letter, with a legalised signature, issued by the host entity; or,</li> <li>b) Presentation of a sponsorship letter, with a legalised signature, issued by a Portuguese or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay.</li> </ol> </li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
