<b>Police clearance certificate</b> , issued by the competent authority of the country of the applicant's nationality or of the country where the applicant has lived for over a year (not required for minors under sixteen years of age), with the Hague Apostille (if applicable) or legalised.  <i>Note: Police clearance is required to be submitted with a UAE MoFA stamp and must be legalized by the Portuguese embassy prior to submitting an application to VFS; otherwise, it is not accepted.</i>  <i>*Please note that an appointment at the Portuguese Embassy is mandatory for legalization purposes. <b>SPECIFIC DOCUMENTS</b>		
Proof of family ties that justify the accompaniment.  For this purpose, family members mean: <ul style="list-style-type: none"> <li>The spouse;</li> <li>Minors or disabled children dependent on the couple or one of the spouses;</li> <li>Minors adopted by the applicant (when single), by the applicant or by the spouse, as per decision of the competent authority of the country of origin, provided that the law of that country recognises adopted children with rights and duties identical to those of natural filiation and that decision is recognised by Portugal;</li> <li>Children of legal age, dependent on the couple or one of the spouses, who are single and studying at an educational establishment in Portugal;</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>

<ul style="list-style-type: none"> <li>Children of legal age, dependent on the couple or one of the spouses, who are single and studying, whenever the holder of the right to family reunification has a residence permit issued under Article 90.<sup>o</sup>-A;</li> <li>First-degree relatives in the ascending line of the resident or their spouse, provided they are dependent on them;</li> <li>Minor siblings, provided they are under the guardianship of the resident, in accordance with a decision issued by the competent authority of the country of origin and that decision is recognised by Portugal.</li> <li>The partner who, in Portugal or in other country, with whom the foreign resident citizen contracted a civil partnership, duly proven under the law;</li> <li>Single minors or disabled children, including adopted children of the partner of the civil partnership, provided they are legally under the protection of the partner.</li> </ul>		
<b>Proof of availability of stable and regular resources</b> , sufficient for the needs of the residency visa applicant and the accompanying family members during the intended period of stay or for the period of 12 months, whichever is shorter, determined under the provisions of Article 2(2) of Ordinance nº 1563/2007 of 11th of December.	<input type="checkbox"/>	<input type="checkbox"/>
<b>ADDITIONAL DOCUMENTS FOR MINORS</b>		
<b>Minors who are not traveling with both parents or are traveling with a third person:</b> <ul style="list-style-type: none"> <li>a travel authorization issued by the parent with whom the minor is not traveling or by both parents, with a legalised signature; <b>or</b></li> <li>a court decision (when applicable) authorizing the minor to travel and stay in Portugal for the foreseen period according to the purpose of stay, with the Hague Apostille (if applicable) or legalised; <b>and</b></li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>

<b>CPLP citizens are exempted from presenting:</b> <ul style="list-style-type: none"> <li>Travel insurance,</li> <li>Return transport ticket; and,</li> <li>Means of support, <b>upon presentation of a sponsorship letter in the following terms:</b> <ol style="list-style-type: none"> <li>Presentation of a sponsorship letter, with a legalised signature, issued by the host entity; <b>or,</b></li> <li>Presentation of a sponsorship letter, with a legalised signature, issued by a Portuguese or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay.</li> </ol> </li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
<b>Notes:</b> <ul style="list-style-type: none"> <li>Failure to submit all the necessary documents may lead to the rejection of the visa application.</li> <li>The Consular Post reserves the right to request supplementary documents if necessary.</li> <li>Even if all the requested documents are submitted, it does not mean that a visa will automatically be granted.
