OR, ALTERNATIVELY, Presentation of a sponsorship letter, signed by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, which guarantees food and accommodation for the visa applicant, as well as the replacement of removal costs, in case of irregular stay.
