Proof of the existence of <b>means of support</b> upon presentation of a sponsorship letter, with legalised signatures, signed by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging & boarding, as well as all the removal costs, in case of irregular stay.			
In the case of patients traveling under Cooperation Agreements, the proof of means of support and accommodation may be replaced by a statement issued by the Embassy in Lisbon ensuring the referred conditions.
