<p>CPLP citizens are exempt from presenting:</p> <ul style="list-style-type: none"> Travel insurance, Return transport ticket; and, Means of support, upon presentation of a sponsorship letter in the following terms: <ul style="list-style-type: none"> a) Presentation of a sponsorship letter, with a legalised signature, issued by the host entity; or, b) Presentation of a sponsorship letter, with a legalised signature, signed by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay . 	<input type="checkbox"/>	<input type="checkbox"/>
