<b>Document certifying that the transfer:</b> <ul style="list-style-type: none"> <li>• Is occurring within the same company or corporate group, and that the establishment located in Portuguese territory must provide services equivalent to those provided by the establishment from which the foreign citizen is being transferred; <b>or</b></li> </ul>

<p><b>CPLP citizens are exempt from presenting:</b></p> <ul style="list-style-type: none"> <li>• Travel insurance,</li> <li>• Return transport ticket; and,</li> <li>• Means of support, <b>upon presentation of a sponsorship letter in the following terms:</b></li> </ul> <ul style="list-style-type: none"> <li>a) Presentation of a sponsorship letter, with a legalised signature, issued by the host entity; or,</li> <li>b) Presentation of a sponsorship letter, with a legalised signature, signed by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay .</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
