<b>TEMPORARY STAY VISA FOR AMATEUR SPORTS – CPLP MOBILITY AGREEMENT</b>		
<b>CPLP citizens are exempted from presenting:</b>		
<ul style="list-style-type: none"> <li>• Travel insurance,</li> <li>• Return transport ticket; and</li> <li>• Means of support, upon presentation of a sponsorship letter in the following terms: <ul style="list-style-type: none"> <li>a) Presentation of a sponsorship letter, with a legalised signature, issued by the host entity; or, Presentation of a sponsorship letter, with a legalised signature, issued by a Portuguese citizen or a foreign citizen with a residence permit in</li> <li>b) Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay.</li> </ul> </li> </ul>

<ul style="list-style-type: none"> <li>• Failure to submit all the necessary documents may lead to the rejection of the visa application.</li> <li>• The Consular Post reserves the right to request supplementary documents if necessary.</li> <li>• Even if all the requested documents are presented, it does not imply the automatic granting of the visa.
