<b>Police clearance certificate</b> , issued by the competent authority of the country of the applicant's nationality or of the country where the applicant has resided for over a year (not required for minors under sixteen years of age), with the Hague Apostille (if applicable) or legalised.  <i>Note: Police clearance is required to be submitted with a UAE MoFA stamp and must be legalized by the Portuguese embassy prior to submitting an application to VFS; otherwise, it is not accepted.</i>  <i>*Please note that an appointment at the Portuguese Embassy is mandatory for legalization purposes. <b>CPLP citizens are exempt from presenting:</b> <ul style="list-style-type: none"> <li>Travel insurance;</li> <li>Return transport ticket; and</li> <li>Means of support, <b>upon presentation of a sponsorship letter</b>, with legalised signature, issued by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay.</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
<b>Notes:</b> <ul style="list-style-type: none"> <li>Failure to submit all the necessary documents may lead to the rejection of the visa application.</li> <li>The Consular Post reserves the right to request supplementary documents if necessary.</li> <li>Even if all the requested documents are presented, it does not imply the automatic granting of the visa.
