### ADDITIONAL DOCUMENTS FOR MINORS

- a court decision (when applicable) authorizing the minor to travel and stay in Portugal for the foreseen period according to the purpose of stay, with the Hague Apostille (if applicable) or legalised; and

### TEMPORARY STAY VISA FOR ACADEMIC OR PROFESSIONAL TRAINING COURSE – CPLP MOBILITY AGREEMENT

**CPLP citizens are exempt from presenting:**

- Travel insurance;
- Return transport ticket; and
- Means of support, **upon presentation of a sponsorship letter in the**

**following terms:**

- a) Presentation of a sponsorship letter, with a legalised signature, issued by the host entity; or,
- b) Presentation of a sponsorship letter, with a legalised signature, issued by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay.

**Notes:**

- Failure to submit all the necessary documents may lead to the rejection of the visa application.
- The Consular Post reserves the right to request supplementary documents if needed.
- Even if all the requested documents are presented, it does not imply the automatic granting of the visa. The visa fee is not refunded if the visa is refused.
