<ul> <li>Adult sons, dependent on the couple or on one spouse, single and that study in a teaching establishment in Portugal,</li> <li>Under aged sons, under the care of the couple, or of one spouse, that are single and study, if the holder of the right to family reunion is the bearer of a residence permit issued under the article 90.º-A,</li> </ul>			
<ul> <li>The ascendants in direct line and in first degree of the resident or of his spouse, if they are under their care,</li> <li>Under aged brothers, if they are dependent of the resident, as declared by a decision of the competent authority of the country of origin and that the decision be recognised in Portugal,</li> <li>The partner, in Portugal or in other country, with whom the foreign resident citizen has a civil union, duly proved under the law,</li> <li>Unmarried sons, under aged or incapable, including adopted sons of the partner in the civil union, if they are legally under the protection of the partner.</li> </ul>
