<b>ADDITIONAL DOCUMENTS FOR MINORS</b>

<p><b>CPLP citizens are exempted from presenting:</b></p> <ul style="list-style-type: none"> <li>• travel insurance, and,</li> <li>• return transport ticket.</li> </ul> <p><b>Upon presentation of statement of responsibility in the following terms:</b></p> <ul style="list-style-type: none"> <li>• Presentation of a term with a recognized signature issued by the host entity for interns or workers, as well as by the organization responsible for student exchange or volunteer programs; <b>or</b>,</li> <li>• Presentation of a term of responsibility, with a recognized signature, signed by a Portuguese citizen or a foreign citizen, with a residence permit in Portugal, which guarantees food and accommodation for the visa applicant, as well as the replacement of removal costs, in case of irregular stay.</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
