## INTRODUCTION

A Visa application has to be submitted in person at the Consulate/service that serves the applicant's legal area of residence: <https://portaldascomunidades.mne.gov.pt/pt/rede-consular>

Visa applications in the United Kingdom, to visit or reside in Portugal, are done exclusively through **VFS Global**.

For overall information and the documentation required to apply for a Portuguese National Visa (Residence Visa or Temporary Stay) please read this document carefully and/or visit the Portuguese Foreign Office website (MNE):

A **Temporary Stay Visa** is used for stays of over 90 days and up to 1 year, with multiple entrances allowed into Portugal.

A **Residence Visa** is for applicants that wish to stay in Portugal for more than 1 year. The applicant will initially be granted a visa valid for 120 days with up to two entrances into Portugal, followed by an appointment with AIMA in Portugal, to acquire a Residence Permit. **A Temporary Stay visa application can take 30 days for a decision. A Residence visa application can take 60 days for a decision.** More information regarding deadlines for National Visa applications can be found in the link below:

All public documents must be legalized per conventions in place, including, but not limited to, Civil Registry documentation, such as marriage and birth certificates, Criminal Record Certificates, professional certificates and diplomas. This legalization can be made through the Apostille (if applicable) or by utilizing the relevant Portuguese Consulate/service that serves the place of origin of the document in question:

**Public documents from the United Kingdom, including the Criminal Record Certificate (ACRO) and Civil Registry documentation, must be legalized through the Apostille, which can be obtained from the Legalization Office:** <https://www.gov.uk/get-document-legalised>. Certified translations are also required for documents not written in English or Portuguese.

The Term of Responsibility concerning the conditions of stay within Portuguese territory will only be accepted if the subscriber's signature is duly recognized by a Notary that serves the sponsor's legal area of residence.

*Note:*

- *Failure to submit all the necessary documents may lead to the rejection of the visa application.*
- *The Consular Post reserves the right to request documents other than those mentioned above whenever deemed convenient.*
- *Even if all the requested documents are presented, it doesn't imply the automatic granting of the visa. Refusal of the visa application shall not entitle to a reimbursement of the visa fee.*

- *Financial resources: Ordinance nº 1563 /2007, of the 6<sup>th</sup> of December*
- *Applicants can appeal refusal to grant a visa, in compliance with Portuguese domestic law. Available options being:*
  - *Issue a complaint, within 15 days following acknowledgment of refusal, against the issuer of the refusal (in compliance with article 191, Administrative Process Code (CPA));*
  - *Appeal the decision of refusal, within three months following notification, (in compliance with article 59 Administrative Court Process Code, CPTA and paragraph 2 of artigo 193 CPA), to the Minister of Foreign Affairs - email [din@mne.pt](mailto:din@mne.pt)*
  - *Bring an action to competent court (Administrative Court, Lisbon, Article 22 by suppletion, CPTA), within three months of notification of refusal (Articles 69 and 59 Administrative Court Process Code, CPTA) requesting the overruling of the refusal, and the granting of the required lawful act.*
  - *The referred options are not mutually exclusive. As such, the applicant can appeal to the Minister and, depending on the results of such appeal, continue towards litigation (Paragraph 4, Article 59, CPTA).*
  - *The applicant can also appeal the decision and bring an action simultaneously to the administrative court, without waiting for the results of the appeal (in compliance with paragraph 5 of article 59 CPTA).*

## **RESIDENCE PERMIT FOR INVESTMENT PURPOSES – ARI/GOLDEN VISA**

The rules governing the granting of Residence Permit for Investment (ARI/Golden Visa) enable third country nationals to obtain a temporary residence permit to conduct business activities with visa waiver to enter national territory. The beneficiaries of ARI / Golden Visa are entitled to:

- Residence visa waiver for entering Portugal;
- Living and working in Portugal, on condition that they stay in Portugal for a period of 7 or more days, in the first year, and 14 or more days, in the subsequent years;
- Visa exemption for travelling within the Schengen Area;
- Family reunification
- Applying for permanent residence (pursuant to the Aliens Act – Act number 23/2007 of 4 July with the current wording );
- Applying for Portuguese citizenship, by naturalization, provided all other requirements set out by the Nationality Act are fulfilled (Act number 37/81 of 3 October, as amended);

All third country citizens who conduct an investment activity, as an individual businessperson or through a company set up in Portugal or in another EU Member State and who, in addition, are stably settled in Portugal, provided these citizens fulfil the quantitative requirements and the time requirements set out by the relevant legislation, may apply for a Residence Permit for Investment, by one of the following routes:

- Capital transfer with a value equal to or above 1.5 million Euros;
- The creation of, at least, 10 job positions;
- The purchase of real estate property with a value equal to or above 500 thousand Euros;
- The purchase of real estate property, with construction dating back more than 30 years or located in urban regeneration areas, for refurbishing, for a total value equal to or above 350 thousand Euros;
- Capital transfer with a value equal to or above 500 thousand Euros for investing in research activities conducted by public or private scientific research institutions involved in the national scientific or technologic system;
- Capital transfer with a value equal to or above 250 thousand Euros for investing in artistic output or supporting the arts, for reconstruction or refurbishment of the national heritage, through the local and central authorities, public institutions, public corporate sector, public foundations, private foundations of public interest, networked local authorities, local corporate sector organizations, local associations and public cultural associations, pursuing activities of artistic output, and reconstruction or maintenance of the national heritage;
- Capital transfer of the amount of 500 thousand Euros, or higher, for the acquisition of units of investment funds or venture capital fund of funds dedicated to the capitalisation of companies, capital injected under the Portuguese legislation, whose maturity, at the moment of the investment, is, at least, of five years and, at least, 60% of the investments is realized in commercial companies with head office in national territory;

- Capital transfer of the amount of 500 thousand Euros, or higher, for constitution of a commercial society with head office in the national territory, combined with the creation of five permanent working jobs, or for the reinforcement of the share capital of a commercial society with head office in national territory, already existing, with the creation or keeping of working jobs, with a minimum of five permanent jobs, and for a minimum period of three years;
- Family reunification.

## **RIGHT TO LIVE IN PORTUGAL OF EU / EEE / ANDORRA / SWITZERLAND NATIONALS AND THEIR FAMILIES**

According to the provisions of Act 37/2006 of 9 August, the following citizens have a right to enter, remain and reside in Portugal:

- The Nationals of all European Union Member-States (EU) that travel or reside in Portugal, as well as their family members travelling or reunifying with them;
- The nationals of States party to the European Economic Area, Principality of Andorra and Switzerland, as well as their family members;
- The family members of Portuguese citizens regardless of their nationality.

Current legislation defines as family members of citizens from the European Union, Iceland, Liechtenstein, Norway, Principality of Andorra and Switzerland, the following:

- Spouse;
- Relatives in the descending line under 21 years old;
- Relatives in the descending line over 21 years, that prove to be dependent from the rights holder;
- Relatives in the ascending line if dependent of the rights holder.

## MINORS

### **Children below 18 must present the following documents:**

- a) Unabridged birth certificate showing biological parents names; if the birth certificate is not in English or Portuguese, then a translation by a certified translator is also required.
- b) Original passports of both parents, or certified copy of the biodata page of the passports.
- c) Letter of consent of parental authority or legal guardian

In the case of sole custody, the following documents must be submitted:

- a) birth certificate mentioning one parent in English or Portuguese; or
- b) death certificate of absent parent in English or Portuguese; or
- c) court ruling in English or Portuguese.

In case of minors, application forms should be signed by the parent holding parental responsibility or legal guardian;

When minors are not travelling with both parents, or are travelling with a third person, a travel authorization, with legalized signature, of one or both parents respectively, or a court order, is required.

UK public documents, including Criminal Record Certificate and Civil Registry documentation, do not require any certification/apostille or translation. Public documents that are not of UK or Portuguese origin should be legalized per conventions in place, including, but not limited to, Civil Registry documentation, such as marriage and birth certificates, and Criminal Record Certificates. This legalization can be made through the Apostille (if applicable) or by utilizing the relevant Portuguese Consulate/service that serves the place of origin of the document in question: <https://portaldascomunidades.mne.gov.pt/pt/rede-consular>. Certified translations are also required for documents not written in English or Portuguese.
