<b>Proof of accommodation;</b> Lease agreement signed, or letter from inviting institution, or declaration from family member residing in Portugal (minimum of 6 months).

Proof of family ties that justify the accompaniment.  For this purpose, family members mean:  • The spouse;  • Minors or disabled children dependent on the couple or one of the spouses;  • Minors adopted by the applicant (when single), by the applicant or by the spouse, as per decision of the competent authority of the country of origin, provided that the law of that country recognises adopted children with rights and duties identical to those of natural filiation and that decision is recognised by Portugal.  • Children of legal age, dependent on the couple or one of the spouses, who are single and studying at an educational establishment in Portugal;  • Children of legal age, dependent on the couple or one of the spouses, who are single and studying, whenever the holder of the right to family reunification has a residence permit issued under Article 90.º-A;
