<p><b>Notes:</b></p> <ul style="list-style-type: none"> <li>• Applicants are required to pay the Visa Fee for National Visa D/E (all categories) by way of a money order or Banker / Cashier check in favor of the “<b>Consulate General of Portugal</b>”. VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application.</li> <li>• Failure to submit all the necessary documents may lead to the rejection of the visa application.</li> <li>• The Consular Post reserves the right to request supplementary documents if necessary.</li> <li>• Even if all the requested documents are submitted, it does not imply that a visa will automatically be granted.
