<p><b>CPLP citizens are exempt from presenting:</b></p> <ul style="list-style-type: none"> <li>• Travel insurance.</li> <li>• Return transport ticket; and</li> <li>• Means of support <b>upon presentation of a sponsorship letter in the following terms:</b> <ol style="list-style-type: none"> <li>a) Presentation of a sponsorship letter, with a legalized signature, issued by the host entity; <b>or,</b></li> <li>b) Presentation of a sponsorship letter, with a legalized signature, issued by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay.</li> </ol> </li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
<p><b>Notes:</b></p> <ul style="list-style-type: none"> <li>• Applicants are required to pay the Visa Fee for National Visa D/E (all categories) by way of a money order or Banker / Cashier check in favor of the “<b>Consulate General of Portugal</b>”. VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application</li> <li>• Failure to submit all the necessary documents may lead to the rejection of the visa application.</li> <li>• The Consular Post reserves the right to request supplementary documents if needed.</li> <li>• Even if all the requested documents are presented, it does not imply the automatic granting of the visa.
